TRANS-CANADA AIR LINES

Mr. Drew: Will the minister explain the reason for this change?

Mr. Howe (Port Arthur): The bill to amend the Atomic Energy Control Act as originally drawn required a resolution, as it involved expenditure of money. The bill as at present drawn does not require a resolution and the government has decided to withdraw the resolution and present the bill in the form as now revised.
