CANADIAN CONSTITUTION

ANNOUNCEMENT OF AGREEMENT ON METHOD OF AMENDMENT

[Translation]

Hon. Guy Favreau (Minister of Justice): Mr. Speaker, I have the honour to inform the house of an agreement which will be a landmark in the constitutional evolution of Canada. After years of stalemate, the federal and provincial governments agreed yesterday afternoon, on a definite text conferring on Canadians themselves the unlimited and exclusive power to amend the British North America Act.

As the representative of the federal government in the discussions which preceded the final agreement, I want to pay tribute to my provincial colleagues—attorneys general and other ministers—for their broadmindedness the custody and control of Canadians rather and their patriotism. [Text]

The text of the amending formula announced yesterday by the Prime Minister and premiers is the fruit of arduous and statesmanlike labour by all Canadian governments, both federal and provincial. It was imposed on no one, but forged from the free consent of men who recognize themselves as Canadians first. As chairman of the preparatory conference of attorneys general I was proud that my colleagues adopted unanimously the following resolution, moved by Nova Scotia and seconded by Manitoba:

That the report made by the chairman at the end of the conference this morning, together with the consolidated formula submitted by the federal delegation bearing date October 8, 1964, as amended in accordance with the report of the drafting committee dated October 13, 1964, and adopted this morning, be submitted to the conference of Prime Minister and premiers as the report of this conference of attorneys general.

By accepting our draft with like unanimity the Prime Minister and premiers swept away rests upon a deep and abiding unity.

I am pleased to assure hon, members that the government of Canada intends to place the new amending formula on the order paper at the earliest convenient moment. After the Canadian parliament has adopted the formula in a joint address, and after each province has formally approved it as well. the parliament at Westminster will be asked to enact the formula as part of the constitution of Canada. I am sure that Canadian as well as British parliamentarians will be relieved to consider that this will be the last time such action will be required. As of that moment, Canada's constitution will indeed be wholly and truly Canadian.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, first may I say that Canadians as a whole will be glad to learn that their constitution will hereafter be in endeavoured to bring about agreement. A
