Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, I draw the attention of the house to an unseemly delay in the reply to starred question No. 761. It was presumed that starred questions would be answered within three days. This question has to do with protests from the mayor and other citizens of Rock Island, Quebec, against the construction of a new post office. I think this is the first time in many years that any group within a municipality has protested against government expenditures. This is the first time a municipality has been forced to accept those expenditures regardless of their feeling. I do not know whether that is the reason for the delay, but certainly you would not think it would take such a long time to answer a question as simple as this one.

Hon. Donald S. Macdonald (President of the Privy Council): Mr. Speaker, perhaps I could deal with this matter. As you may notice, the question is not addressed to any single minister but to the entire government. Therefore to obtain a comprehensive answer to the question it is necessary to seek advice from all departments of government as to whether they received notice of the protest.

Some hon. Members: Oh, oh.

Mr. Macdonald (Rosedale): In any event, if the question had been drafted better the answer could have been forthcoming earlier.

Some hon. Members: Hear, hear.

Mr. Macdonald (Rosedale): But I point out that, as with the question with respect to the Centennial Medal which had to be answered at such heavy expense today, it does take time to answer some of these questions.

Some hon. Members: Hear, hear.

Mr. Diefenbaker: The hon. member will identify himself even to the Prime Minister if he keeps on like that. Unless there is no communication between government departments, there should be no difficulty in these questions.
