

548,133 abortions in Canada. What a grizzly compendium! Half a million babies were murdered in the womb.

U.S. hospital authorities revealed that they had collected \$68,000 from commercial firms for organs of aborted and dead premature babies.

Canada does not keep statistics on the number of aborted babies born alive. Sometimes something goes wrong in the abortion process and a baby is born alive. In the U.S., some of these babies have lived while others were left to die. In fact charges have been laid against people who stood by and did nothing to save the life of a live aborted child.

We seem to have rights for everyone except the unborn. It is high time that we recognized, by legislation, the rights of the unborn; their right to live!

TORONTO POLICE FORCE'S AID TO COMMONWEALTH CARIBBEAN ISLANDS

Not only does the Government care about the underdeveloped areas of the Caribbean, it is backing this up with action, action that will directly benefit those who are most in need. This is a Government with a heart.

INCOME TAX ACT
