## CANADA PENSION PLAN

INQUIRY AS TO REFUNDS TO EMPLOYERS

It concerns the overpayment by employers of contributions to the Canada Pension Plan. This overpayment is estimated to be as high as \$15 million. The minister advised the house on April 25 that when a survey or a study had been made of the situation he would tell the house the method or form in which these overpayments would be refunded. Is the minister now in a position to make this statement?

Hon. E. J. Benson (Minister of National Revenue and President of the Treasury Board): First of all, Mr. Speaker, I do not have the figure in front of me but the overpayment was vastly overestimated, and the figure turned out to be almost identical with what the government had forecast. Second, I would like to indicate that we are presently consulting one of the provinces on what action if any would be agreeable in this particular situation, and in due course we will consult all the provinces.

Mr. Hales: Mr. Speaker, I have a supplementary question. Can the minister inform the house what is the amount he referred to?

Mr. Speaker: Order, please. I wonder whether this type of information can be asked at this time.
