Have any cultivation leases or any other form of agricultural lease been granted on the Pasqua Indian Reserve and, if so (a) to whom have the leases been extended (b) what is the acreage in each lease (c) what is the life of each lease and when does each expire (d) what is the crop sharing arrangement for each lease?
