Hon. John N. Turner (Minister of Justice): No, Sir. We will make an announcement in the House as soon as feasible.

Mr. Stanfield: In view of what I understood was the assurance given by the minister that a proposal would be put before the House in such a manner that it could be discussed, is the minister prepared to give the House an assurance that this matter will not be introduced and a conclusion forced upon the House before the expiry date of the Turner act on April 30?

Mr. Turner (Ottawa-Carleton): My assurance was given and it stands. As for the date of April 30, the hon. gentleman will have to wait and see.

Mr. Stanfield: I have a further supplementary question, Mr. Speaker. I should like to ask the minister why he cannot tell the House, or rather when he will tell the House, what action the government proposes to take and not simply stall and procrastinate on this important matter?

Mr. Speaker: Order, please. That is hardly a supplementary question.

Mr. Eldon M. Woolliams (Calgary North): My supplementary question is simple and straightforward, and I hope I will get the same kind of answer. Will the announcement the minister will be making be made before April 30 next?

Mr. Turner (Ottawa-Carleton): I cannot be categorical about that.

OPPORTUNITIES FOR YOUTH PROGRAM—APPLICATION CRITERIA—EXPLANATION OF REFUSALS—INCREASE IN MONEY ALLOCATED

Mr. David Lewis (York South): I should like to address a question to the Prime Minister with regard to the student employment program about which he told the House some time ago. It arises out of a suspicion across the country about the criteria which have been used for the acceptance or refusal of proposals made to the Department of the Secretary of State. I should like to ask the Prime Minister whether he could take steps to make sure that those whose programs have been refused will receive a full explanation of the reasons for refusal and an elaborated idea of the criteria which are being used in judging these proposals?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the rumours on which the question is based are obviously wrong, because no program has either been accepted or refused as of this date. Obviously, in view of the figures which were given by the Secretary of State, we will have to refuse some of the proposals, and reasons will be given why they are refused.

Mr. Lewis: I am glad to stand corrected, Mr. Speaker, but will the Prime Minister or the Secretary of State

assure the House that proposals which are made will be dealt with a great deal more rapidly, and that machinery for discussing the proposals will be made available to the people who have ideas instead of making them wait for weeks before they even receive an acknowledgement?
