## MANPOWER

SUGGESTED INTEGRATION OF MANPOWER AND UNEMPLOYMENT INSURANCE OFFICES—GOVERNMENT POSITION

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, my question is directed to the Minister of Manpower and Immigration and arises from the speech made by the minister to the Toronto Chamber of Commerce on September 23 last in which he suggested that the number one priority was setting up a partnership between the Unemployment Insurance Commission and manpower offices. As unemployment is advancing at the same time as increases in job vacancies are advancing, can the minister tell the House when this partnership is to be established.

Hon. Robert K. Andras (Minister of Manpower, and Immigration): Mr. Speaker, it has been established in the last two years and is working increasingly effectively.

Mr. Dinsdale: A supplementary question, Mr. Speaker. Can the minister inform the House whether the partnership to which he refers and which he says has already been established goes further than putting the two offices under one roof? Does it involve the integration of these two important functions in the same ministry?

Mr. Andras: Mr. Speaker, I have given members of the House in various forums a great deal of evidence regarding special measures which have been taken over the last two years; and, most recently, some fairly detailed description was given before the Standing Committee on Labour, Manpower and Immigration about the special job placement drive, which was a cooperative effort between manpower and the Unemployment Insurance Commission in seven metro centres. It met with considerable success in placing people, in indicating which people are trying to find jobs, and in monitoring the unemployment insurance scheme. I indicated to the committee that it is intended that this successful pilot project, which is a broad one, is being extended across the country.

Mr. Dinsdale: Mr. Speaker, could the minister answer my specific question. Is the minister to reintegrate these two functions which were disintegrated at an earlier time, as this really is the only solution to a satisfactory partnership.

Mr. Andras: Mr. Speaker, I think the hon. member is jumping to a detailed conclusion which may not be supported by a detailed examination. We are pressing, and successfully pressing, for increased coordination and cooperation between these two major operations, and I am not satisfied that an organizational integration is the answer to the particular problem.

Mr. Dinsdale: So, the answer is, no.
