STACKING OF DREE AND IT&C GRANTS OR LOANS

Question No. 2,172—**Mr. Herbert:**

Can a company receive loans and/or subsidies from the Department of Industry, Trade and Commerce and from the Department of Regional Economic Expansion and (a) if so, under what conditions (b) if not, what determines to which department a company should apply?

Hon. Pierre De Bané (Minister of Regional Economic Expansion): The reply for Department of Regional Economic Expansion is as follows: yes, it is possible for a company to receive for the same project financial assistance from the Department of Industry, Trade and Commerce (IT&C) and the Department of Regional Economic Expansion (DREE), for example, a loan guarantee from IT&C and a regional development incentive from DREE.

To receive such assistance, the project must qualify under and meet the objectives of each department's programs. In addition, it must be demonstrable that the project needs both forms of financial assistance in order to be viable. In cases where only one form of governmental assistance is considered necessary to satisfy the financial need, then only the relevant department would make that assistance available.
