APPRECIATION OF ACHIEVEMENTS OF FATHERS OF CONFEDERATION—FAITH IN CANADA'S FUTURE—MOTION UNDER S.O. 43

CALL FOR INFORMATION ON SALARIES OF ORDER IN COUNCIL APPOINTEES—MOTION UNDER S.O. 43

Mr. Tom Cossitt (Leeds-Grenville): Madam Speaker, I rise on a matter of urgency stemming from the arrogant refusal of the government—

Some hon. Members: No.

Mr. Cossitt: Perhaps you could wait until you hear it.

Madam Speaker: Order, please.

Mr. Cossitt: —to reveal the salaries of over 2,000 order in council appointments, such refusal providing sharp contrast to the open disclosure policy of the previous Progressive Conservative government, and positions consisting mostly of awards to Liberal party sacred cows. I move, seconded by the hon. member for Parry Sound-Muskoka (Mr. Darling):

That this House expresses extreme condemnation of government action in hiding from the Canadian people what they are paying through their taxes in salaries for over 2,000 high-ranking public servants, which provides a complete mockery of the government's declaration of support for more freedom of information to the public; and, finally, this House requests the Prime Minister to reveal complete details immediately of all such salaries, and that the blocking of such information be no longer permitted by the undue influence and advice of such persons as Michael Pitfield, a servant and not the master of the Canadian people.

POSSIBLE DANGER OF RADIATION FROM U.S. EMISSIONS— GOVERNMENT INVESTIGATION—MOTION UNDER S.O. 43

Mr. Mark Rose (Mission-Port Moody): Madam Speaker, I rise, under the provisions of Standing Order 43, on a matter of urgent and pressing necessity.

In view of reports from Harrisburg, Pennsylvania, to the effect that the accident prone Three Mile Island nuclear power installation is to be vented of its contaminants into the atmosphere, perhaps as early as this weekend, and since the prevailing winds could carry this emission into Ontario and Canada's Atlantic region, I move, seconded by the hon. member for Oshawa (Mr. Broadbent):

That the Secretary of State for External Affairs investigate these reports and, if they are accurate, demand a halt to this potentially dangerous practice until we can be assured that no Canadian man, woman or child is exposed to the dangers of radiation.
