BUSINESS OF THE HOUSE

ALLOCATION OF TIME TO CONSIDER COMMITTEE OF THE WHOLE STAGE OF BILL C-20

Mr. Baker (Nepean-Carleton): Mr. Speaker, yesterday, as you know, the House gave approval in principle to the government's Bill C-20 regarding property tax credit. That having been done, I consulted with my colleagues, the other House leaders, to see whether there would be any possibility of arranging an allotment of time for the Committee of the Whole proceedings. I wish to advise the House that this was done pursuant to Standing Order 75C, and that the representives of the parties were unable to reach an agreement under Standing Order 75A and 75B on the allotment of time for the Committee of the Whole stage on Bill C-20, to amend the Income Tax Act and provide a tax credit with regard to mortgage interest and home owner property taxes.

In those circumstances, Mr. Speaker, I therefore give notice of my intention to move a motion on Friday, December 7, 1979, allocating one sitting day for the consideration of the proceedings at that stage of this bill so this debate can continue.
