Much gratification must be felt by members of the order at the encouraging reports submitted by the grand officers.

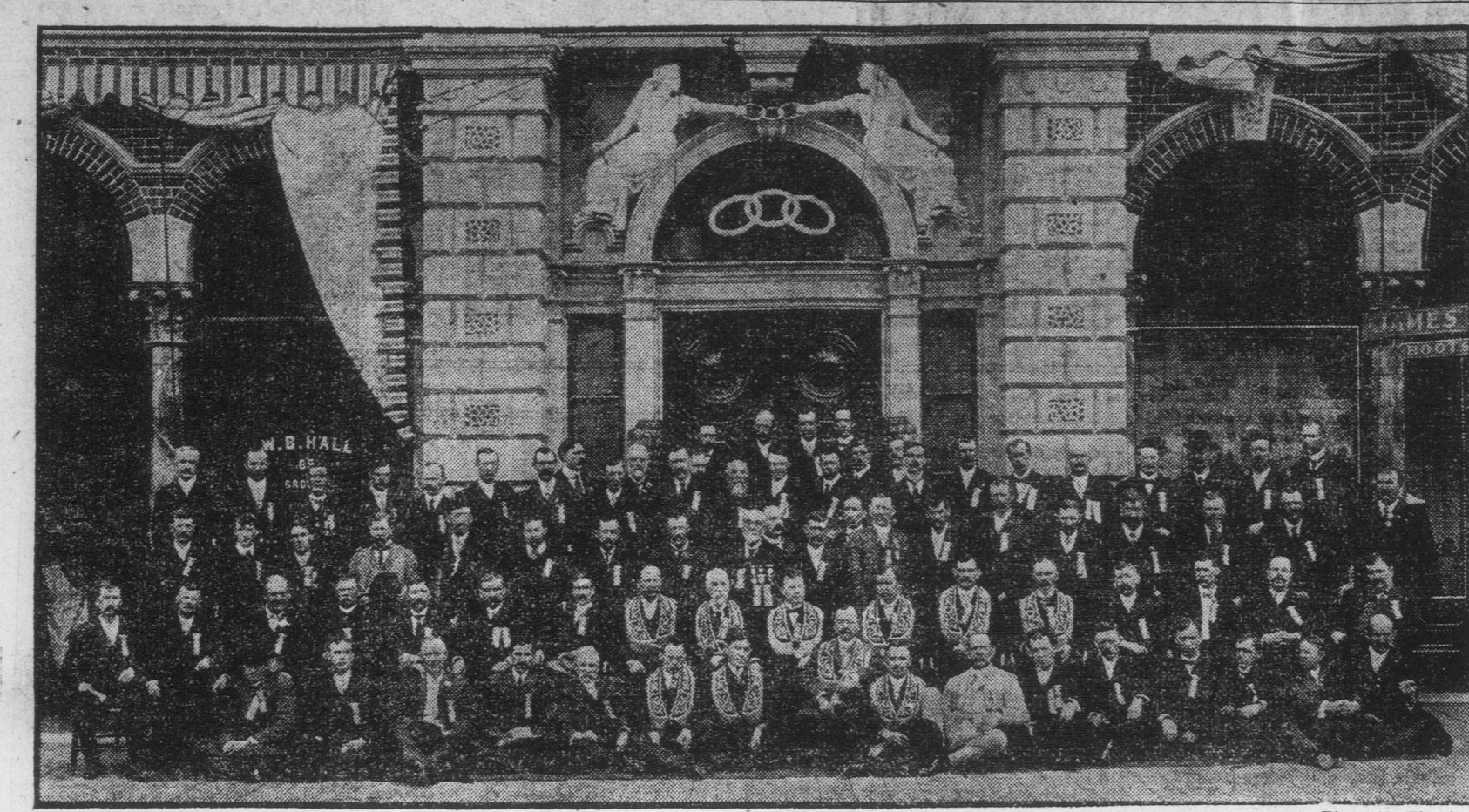
The treasurer's report shows a balance on hand of \$288.45, being much larger than that of last year.
