An Act to amend the Act Chapter 77, of the Consolidated Statutes for Upper Canada, intituled "An Act respecting the action of seduction and the support of illegitimate children."

WHEREAS the remedy provided by the Act respecting the action Preamble. of seduction and the support of illegitimate children, chapter 77 of the Consolidated Statutes for Upper Canada, has proved insufficient in many cases of great hardship in which relief ought to be granted, by 5 reason of the neglect of the persons mentioned therein as being entitled to bring such action, or of their decease, or of their being absent from the Province, or being under other disability:

 - 3. All causes of action that may have arisen within two years previous Act to apply to the passing of this Act, shall be cognizable under this Act in all cases. Courts having jurisdiction in cases of seduction in Upper Canada.
