Agreeable to a Circular from the Clerk of the Peace, dated the 11th instant, and received the 24th, I enclose, for the information of His Excellency the Lieutenant Governor, a Return of the Suits commenced in the Court of Requests for our Division, from the 1st January, 1830, to 1st January, 1831.

The first forty-two Suits have come to trial, and Judgments given in favor of Plaintiff. The next eleven Suits have been entered on the Record, but settled between the Parties in Court; and in the last fourteen Suits, the Plaintiff has been non-suited.

Eight Executions have been issued, but have all been settled without Sale.
