The Great Fire in Charlottetown.

FURTHER DETAILS.

Full Account of the Insurance.

This report of the fire in last issue of the Herald was correct as far as it went, but was necessarily incomplete. The losses by the Insurance Companies were more extensive, but so far as we know to the contrary, they were well founded. We estimated the total loss at \$250,000, and up to this we have no reason to alter the figure, and the amount of insurance at \$105,000, which it actually is, less a few hundred dollars. The following are the amounts insured for by those who were burned out:
