The House of Commons Passes Labouchere's Amendment,

The Motion Carried by 147 to 145, While Half the Members Were Absent-Redmond Kicks Against Rosebery.

#### The British Parliament.

LONDON, March 13. - The statement of Lord Rosebery in the House of Lords yesterday, which has produced such a sensation, is in his exact words as follows:

"Lord Salisbury made one remark on the subject of home rule with which I confess myself in entire accord. He said that before Irish home rule could be conceded by the Imperial Parliament England, as the predominant member of the partnership of the three kingdoms, must be convinced of its justice. That may seem to be a considerable admission, because your lordships well know that the majority of English members elected in England proper are hostile to home rule.'

In the House of Commons John Morley, Chief Secretary for Ireland, insisted that there could be no injury to Ireland in a temporary suspension of the Home Rule Bill. If he supposed that the reconstituted Ministry would not be accorded its views on the Irish question he would not be a member of that Ministry. Home rule had neither been delayed nor abandoned, but would take its place in the course of sequence as had been arranged prior to Mr. Gladstone's retire-As to the Irish party with ment. drawing its support from the Government, he was happy to say there were to signs of any such disastrous and mischievous event. There could be no mistake in the minds of any one who had read the speech made in the House of Lords yesterday by Lord Rosebery that he meant to do all in his power to achieve home rule besides reducing the House of Lords to its proper place, as the Legislative organ is now recognized to be in the minds of the English people.

hers voted in favor of the Labouchere amendment, and 145 against it. The division was moved purposely during

the dinner hour, while one-half the members were absent. Mr. Labouchere was congratulated on his victory, and was chaffingly asked when he would undertake the formation of a Ministry.

The majority of the Ministerialists do not disapprove of Mr. Labouchere's victory, but they are perplexed over the Government's defeat. In looking up precedents it has been found that the only way of getting rid of an amendment like Mr. Labouchere's is by having the House vote on the address

# The Pardoning Power.

Cemanding the Abolition of the House Provincial Rights Upheld by the Supreme Court.

The Claims of Sir Oliver Howat Once

More Sustained.

(Associated Press Dispatch.) OTTAWA, March 13.-The Supreme Court met again this morning, there being on the bench Justices Fournier, Taschereau, Gwynne, Sedgewick and King. Among the judgments delivered was that in the case of the Attorney-General of Canada vs. the Attorney-General of the Province of Ontario. Case dismissed with costs. This is the pardoning power case and Sir Oliver Mowat's legislation has been upheld.

(Special to Hamilton Times.) OTTAWA, March 13 .- The reputation of Sir Oliver Mowat as a constitutional authority was once more upheld by the Supreme Court to-day. The court met at Il o'clock, there being on the bench Justices Fournier, Taschereau, Gwynn, Sedgewich and King. The case of the Attorney- | Cobras Island, as well as Villegaignon. General of Canada vs. the Attorney-General of Ontario was dismissed with costs.

The question in this case is as to the constitutionality of a statute of the Province of Ontario, 51 Vic., chap. 5. The case as presented to the court was in the shape of a statement of claim by the Attorney-General of the Dominion of Canada, asking that the act was ultra vires, and to this was a demurrer on the part of the Attorney-General of Ontario on the ground that the act was constitutional.

The act provided that the Lieutenant-Governor-in-Council had the right to exercise the pardoning power in all cases which came under the Provincial statutes. The constitutionality of the act was upheld in the courts below. To-day the Supreme Court gave the same decision, Justice Gwynne dissenting, by dismissing the appeal of the Dominion with costs.

#### Last of the Association Meetings-Addresses by Messrs, Pearce, Wheaten and Others.

HARROW, March 13 .- The last of the dairy meetings under the auspices of the Western Dairymen's Association was held here yesterday. The attendance was large. A. F. MacLaren, Windsor, vice-president of the Dairymen's Association, presided. There were also present: W. Wheaton, secretary, London; J. S. Pearce, second vice-president, London, and representative farmers from all parts of the country. Wm. McGregor, M.P., presented the prospects of Essex for dairying, it being the best adapted for that above all the counties of Ontario. Prof. Miller spoke on the care of milk, and Mr. Gilbert on the advantages of poultry raising in conjunction with dairying. Farmers and hard times was dealt with by Mr. Pearce, who thought that hard times among the farmers were more imaginary than real, and was the result of their methods being behind the times. Mr. Cleland gave a very practical address on dairy farming, enriched by 21 years of practical experience in the business. Mr. Wheaton talked on the markets and their requirements, and Mr. Ruddick dealt ably with the subject of winter dairying.

The End of the Long Siege in Rio de Janeiro.

Da Gama, the Rebel Leader, Unconditionally Surrenders.

The People Jubilant-Terrible Suffering Caused by the Strife-Feeding

the Poor.

RIO DE JANEIRO, March 14 .- The naval revolution is at an end. The rebel officers have surrendered and thousands of Rio citizens, standing on the hill-tops surrounding the bay yesterday afternoon, cheered loud and long as the insurgent flag was hauled down.

Refusing Admiral da Gama's terms of surrender, President Peixoto at noon yesterday in accordance with the notice he had issued 48 hours before, ordered forth the Santa Cruz, Lage, Sao Joa and the Nichteroy to open upon Fort Villegaignon. This they did, and kept up the cannonading vigorously until I o'clock. Then at 3 o'clock the city forts took up the work and all the other forts joining in they poured a perfect HAIL OF SHOT AND SHELL

upon the rebel ships and upon the forts on This was continued for another hour and then ceased. At 5:55 the rebel's white flag in Fort Villegaignon was hauled down. This was immediately followed by that on Cobras Island, then by those on all the rebel ships in the harbor.

A Government launch had landed officers of Peixoto's Government at Fort Villegaignon five minutes afterward and the victory was complete without either the rebel ships or forts having fired a single shot.

President Peixoto and his Cabinet held a meeting to consider the proposals, and the result of their deliberation was that the President replied that he could not receive any conditional proposals of surrender from persons in active insurrection against the Government of Brazil and that

UNCONDITIONAL SURRENDER alone would be accepted.

Admiral Da Gamathen modified his terms, but the President firmly maintained his original position, gave orders to his artillery forces to have all things in readiness to open fire upon the ships, and then sent word to Da Gama that he might take until 3 o'clock vesterday afternoon to consider the advisability of unconditional surrender before the city batteries began to bombard his vessels.

For the last two days the streets have been packed with people, and all the available trucks and handcarts have been busy carrying household goods and personal effects out of the city. The am cars have been jammed until yesterday noon, when it was learned that the struggle was over. This was most joyful news to the people, who fully expected that a battle was at hand. There has been great suffering in the city. Business houses have been closed, and it has been very difficult to get food. The whole available police force has been on duty constantly, but there has been little disturbance. Almost the whole population is gathered in the center of the city. Probably 100,000 persons have left the city. Railroad transportation to the suburbs is free. The Government is feeding the poor.

#### The Prosecution Drawing a Chain of Evidence Around McWherrell-Short History of the Case.

BRAMPron, Ont., March 24 .- (Special)-The trial of McWherrell and Walker on the charge of murdering James and Eliza Williams, the aged couple, continues before Judge Ferguson. A chain of evidence is being drawn around McWherrell. It will be remembered that on Sunday, Dec. 17, 1893, James Williams and his wife, two old people residing on the Middle road, a mile and a half from Cooksville, had been found dead in their home by the neighbors. It was supposed at the time that they had been murdered by their hired man, who had left their employ on the previous Wednesday. John Cory, the hired man, had surrendered himself, and proved beyond a doubt that he was innocent of the crime charged. McWherrell told Cory in Toronto that he (McWherrell) was going to look for work at Williams', and after the murder McWherrell and Walker were seen in Toronto driving a horse and cutter which the prosecution say belonged to the murdered couple.

Mr. Hardy Effectually Disposes of the Opposition Charges.
