CHICAGO MOBS IN RAGE BRUTALLY BEAT INNOCENT

Fight and Panic in Crowded Street Car This Morning—Strike-Breakers Shoot Into Crowd to Kill—United States Marshals Serving Subpoenas by Hundreds.

Chicago, May 3. — Brutality in the strike today began with a fight and panic in a crowded street car. Two men, mistaken for strike-breakers, were assaulted, and so severely beaten that they had to be taken to a hospital. The affair occurred on a Twenty-sixth street car at Stewart avenue. The victims were Edward Boswell, a colored medical student, and W. Jameson, also colored. The men who committed the assault escaped.

Shooting occurred at Franklin and Madison streets, when a caravan, manned by colored drivers and guards, was attacked by a big crowd. The negroes opened fire at once. Harry Williams and Fred Smith, white men, seated on a paper-laden wagon, narrowly escaped death. A bullet passed through Williams' coat and another through Smith's hat. After the shooting the caravan proceeded on its stormy route.

While driving a wagon load of coal at Franklin and Madison streets, Joseph Scott, a non-union colored teamster, was shot in the right shoulder. He was taken to a police station, where his injuries were dressed. Chief of Police O'Neill is steadily increasing his forces, and he believes he will be able to cope with the situation. He says 1,400 policemen are on strike duty.

Nearly 300 negro strike-breakers refused to work when police called at the non-unionists' headquarters to accompany them to the strike.

MORPHINE IN THE FLOUR

Was Sold to Chinese Villagers and Causes Many Deaths.

San Francisco, May 3. — The steamship Copic brings news of many deaths in the inland section of China. According to a story, it has been the custom to smuggle morphine into that section, as the duty on the drug was very heavy. Recently a number of boxes were smuggled inside a shipment of flour. In some manner the boxes were broken and their contents mixed with the flour.

ROYJ NOT GOING TO VLADIVOSTOCK

Russians May Attempt to Reach Port On the Peninsula of Kamchatka.

Tokio, May 3. — It is rumored that the destination of Vice-Admiral Rozhdestvensky's fleet is Petropavlovsk, on the Peninsula of Kamchatka, instead of Vladivostock. It is said that the Russians have been collecting coal and stores at Petropavlovsk, but it is regarded as improbable that the Russians intend to use Petropavlovsk to any great extent, because its defense from land is considered impossible.

Salvaging Port Arthur Ships.

Tokio, May 3. — The work of salvaging the sunken ships at Port Arthur and Chemulpo is progressing satisfactorily to the Japanese. Details are withheld, but it is believed certain that the Japanese navy will secure several battleships and cruisers.

Left French Waters.

Paris, May 3. — Notwithstanding denials, it now appears that the Japanese officials are carefully observing the continued presence of vessels of the Russian fleet on the Indo-China coast and are seeking information from the French authorities concerning the nature and duration of their stay. The members of the legation have addressed several inquiries to the foreign office, asking particularly whether the ships were inside French waters. The reply given was that all the vessels of the Russian squadron have left French waters. These inquiries appear to indicate the purpose of the Japanese to submit further representations or lay grounds for subsequent action.

Tokio in Procession Escorts Spirits of Dead

Tokio, May 3. — A solemn procession escorting the spirits of the dead soldiers and sailors opened the enshrining ceremony at the Skokonsha Temple today. The impressive Shinto ritual was followed by the throng that filled and surrounded the temple, including thousands of relatives of the dead. High

Chicago, May 3. — Representatives of striking teamsters have voted for a measure which promises more strength to the striking drivers. At a meeting of the joint council a fund of \$25,000 was pledged by the treasurers of the different affiliated unions, and an assessment voted upon which, if lived up to, will mean an income to the strikers of \$30,000 a week.

The weekly assessment is to be furnished by the individual drivers throughout the city, who at present are employed. Each man is to be assessed \$1 a week, and the number of men still employed is in the neighborhood of 30,000.

No sympathetic strike will be called by the Coal Teamsters' Union. All the teamsters of the Crerar-O'Neil Company, which has coal contracts with many of the buildings and firms, went on strike today. It was said the effect of this new addition to the strikers' ranks may be to leave many of the tallest office buildings without fuel to run elevators.

ENGLISH COXEY'S ARMY

London, May 3. — A miniature Coxey's army is forming among the striking army bootmakers of Northamptonshire. It is proposed to march on the war office in London, and lay the men's grievances in regard to pay, etc., before the officials. A band of music has been engaged to accompany the strikers, whose march will probably occupy a week.

AUTONOMY DEBATE CLOSES TONIGHT

Only Four More Speeches To Be Delivered.

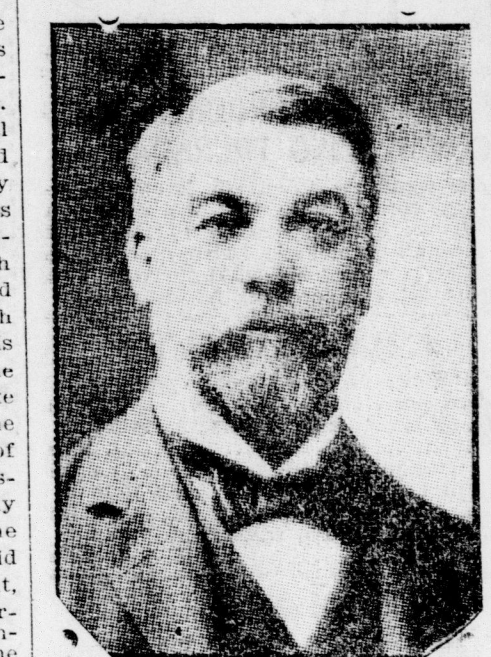
STRONG ADDRESS BY BRODEUR
Says Govt. Has Right to Make School Laws for Provinces—Those of Maclean Challenges.

Ottawa, May 2. — As the end of the autonomy bill debate approaches the speeches seem to preserve variety, and generally reveal fresh phrases which sustain the interest of members. According to the whips' slate the debate will end some time tomorrow night, as only four speeches remain, eight having been delivered today. Hon. Mr. Brodeur, in an address of exceptional strength, argued that the Dominion had the right to give the provinces any kind of constitution they chose. His speech was interrupted by the introduction of Hon. Frank Oliver, fresh from his triumphs in Edmonton, and this gave rise to another brush with Mr. W. F. Maclean, who explained his previous challenges and the good sense, Mr. Claude Macdonnell spoke in favor of religious teaching in the schools, but preferred the reference of the question of jurisdiction in the present case to the courts. Mr. Kennedy and Mr. A. K. Maclean supported the bill, and Mr. W. H. Bennett, Dr. Reid and Mr. R. D. Wilnot opposed it, while Lieut.-Col. Worthington (Conservative), of Sherbrooke, gave the same ineffective in its most essential features. Hon. Mr. Brodeur, Minister of Inland Revenue, who resumed the debate on the autonomy bill, congratulated the House upon the dignity with which the debate had been conducted and the good feeling which had characterized the utterances. He noted with pleasure the unanimity of opinion among the members of the House as to the advisability of erecting the Territories into two provinces. Taking up the suggestion of the leader of the Opposition that no compact, no understanding, existed with regard to the establishment of separate schools in the Northwest Territories as there was in Ontario and Quebec, Mr. Brodeur accepted that objection as an admission that if such an agreement existed Mr. Brodeur would oppose their continuance, and argued at length to show that these schools had been established by the laws of the Dominion, and that, therefore, the people of the Northwest were Continued on page 5.

CHINA IGNORES TREATY

British Merchants Cable Lansdowne Asking Assistance.

Shanghai, May 3. — Seventy leading British merchants in China have wired the following memorial to Lord Lansdowne, secretary of foreign affairs: "The British merchants of this city draw the attention of the home Government to the fact that China ignores the Mackay treaty, rendering the same ineffective in its most essential features. 'China actively opposes the treaty stipulations regarding currency, mining, taxation and navigation. We beg the British Government to take action against the firm who sold the apples on account of misrepresentation.'"

SAV APPLES HAD SEEDS

Fruit Was Sent From Canada to England as Seedless.

London, May 3. — The seedless apples for propagation which were sent by several Canadian growers to England have been pronounced a fraud by a crowd of experts. Recently great interest was aroused by the fact that Messrs. Shearn had purchased a pair of these apples from a Covent Garden salesman for £5, one also being sent to the King. They originally came from America. "The skeptics challenged the Messrs. Shearn to open theirs. This was done before experts and found to contain just as many seeds as a larger one than most apples. Messrs. Shearn stated they would bring an action against the firm who sold the apples on account of misrepresentation."

SUIT AGAINST THE CITY

POLISH STRIKERS

MURDER POLICE
More Desperate Fighting During Night in the Streets of Lodz.

Lodz, May 3. — Four men this morning shot and killed a police sergeant and severely wounded a detective who tried to arrest them. Serious riots occurred in the streets during the night. The military fired on a crowd, killing four persons and wounding several others.

Warsaw, May 3, 12:31 p.m. — An unknown man shot and killed a police sergeant on Hozza street at 9 o'clock this morning. The murderer escaped. It is feared that other disorders will follow in the course of the afternoon. Public nervousness is marked, and there is grave apprehension as to the outcome of the demonstrations and processions which are expected after the conclusion of the masses now being celebrated in the churches in commemoration of the anniversary of the proclamation of the Polish constitution in 1791. There are many soldiers in the streets.

Ex-Premier Holds Levee and Is Warmly Greeted by Friend and Foe.

Hanna Says Chatham Charges Will Be Thoroughly Investigated.

Matheson Wants to Raise Fees of Science School—Horse Racing at Fairs—Estimates.

[Special to The Advertiser.] Toronto, May 2. — A big bunch of American Beauty roses graced the desk of Hon. George W. Ross, when the veteran statesman this afternoon took his seat for the first time as leader of the Opposition in the eleventh Parliament of Ontario. For fifteen minutes before the Speaker's entry Mr. Ross held an informal levee, the members of the House crowding around to welcome him and tender congratulations on his improved health. Among those who greeted him were Mr. Whitney, Mr. Matheson, Mr. Monteth, Mr. Harcourt, Mr. Graham, Mr. McKay, Mr. Auld, Mr. Penne and Mr. Downey.

Mr. Hanna informed Mr. McCoig that if the charges against the Chatham commissioners were sustained, they would be dismissed.

Mr. Matheson briefly explained the reasons for his motion for raising a loan of \$7,000,000, to be expended on the Temiskaming Railway.

The House spent the remainder of the afternoon in committee of supply and good progress was made with the estimates.

Those Chatham Charges.

Mr. McCoig (West Kent) called the House's attention to an article in a Toronto paper referring to license matters in Chatham, and mentioning rumors that hotelkeepers had been approached with offers to secure favorable consideration from the commissioners if money was paid over.

Mr. Hanna replied that he had had the matter called to his attention several days ago, and had ordered that it be fully and thoroughly investigated. The article read contained therein statements which, if true, would leave the Government only one course to pursue, and that was to resign. Meanwhile it would be well not to prejudice the case.

In moving the second reading of his bill to amend the agricultural societies act, Hon. Mr. Monteth explained that it simply made the existing act more definite, and provided for the holding of annual meetings of agricultural societies.

The Minister of Agriculture also secured a second reading of his bill to provide for the incorporation of cold storage associations. The measure increased their usefulness.

House Considers Estimates.

The House resolved itself into committee of supply, and the estimates for education were taken up.

Mr. Labrosse (Prescott) claimed that \$800 was not enough for the French-English training schools in the United Counties of Prescott and Russell. Speaking of the bilingual schools, he pointed out that twenty years ago the teachers in the United Counties were incompetent and unqualified, while English was never spoken in all. Hon. G. W. Ross had established training schools, and today the teachers were all qualified, and English was taught every day. The time had come, however, when the work of the training schools should be extended. Mr. Labrosse claimed that the people were well satisfied with the services of the present inspector of bilingual schools.

In discussing the estimates for the School of Practical Science, Hon. Mr. Matheson said he believed the fees should be raised. There was no reason why a young man should get for \$85 a year in Toronto what would cost him \$175 a year at McGill.

Mr. Harcourt vigorously opposed the idea of raising the fees, as farmers' sons could not afford to pay more than they now do for their education.

Mr. Penne (Kingston) also made a plea for low fees, and Mr. Gurney, who followed, said that the fees should not be raised. The students of that institution, or rather the majority of them, were sons of poor parents, and they could not afford the fees that were imposed at present.

The Premier said that there had been no intimation implied or otherwise by any member of the Government, either in the House or out of it, to raise the fees of the School of Practical Science or any other institution. On an item of \$63,000 for superannuated teachers, Mr. Gurney said that if that sum was paid to the teachers some account should be taken of the fund to find out exactly how it stood.

The estimates of the Provincial Secretary's department were passed practically without discussion.

A lengthy discussion took place over the wiping out of grants to the Cattle Breeders' Association, Swine Breeders' Association, and Poultry Association. Hon. Mr. Monteth and Hon. Mr. Whitney contended that these money could be applied more advantageously to agricultural interests than by giving them to Messrs. Gurney and Harcourt. An appropriation of \$5,500 for the Winter Fair at Guelph had been made instead.

Replying to a question, Hon. Adam E. R. Oler (Toronto) said the Horse Show did not directly benefit from the \$2,000 granted the Horse Breeders' Association. He said the association gave some of the money in prizes, but took away much more than it gave. The association made about \$3,000 out of the Horse Show. The total of \$1,000. The Speaker left the chair at 6 p.m.

Horse Racing at Fairs.

At the evening session. In considering the item of \$73,110 for agricultural societies, a long discussion took place on the question of horse racing at fairs.
