## LABOUR CONDITIONS

TEXTILE MILLS IN MONTREAL AND VALLEYFIELD

On the orders of the day:

Mr. ANGUS MacINNIS (Vancouver East): Before the orders of the day are called I should like to put a question to the Minister of Labour. Have representatives of the textile workers asked for an appointment with the Minister of Labour to discuss the labour dispute between the textile mills in Montreal and Valleyfield and the textile workers, and is there anything the minister can do in connection with this dispute?

Hon. HUMPHREY MITCHELL (Minister of Labour): I think about twenty or thirty hon, members received similar telegrams, and they came to see me yesterday. I want to thank my hon. friend for giving me notice of this question. My reply is that a telegram addressed to myself by R. Kent Rowley, Canadian director of the United Textile Workers' Association, was received yesterday. On my behalf, Mr. M. M. Maclean, director of industrial relations of the Department of Labour, sent the following answer:

Retel to Hon. Humphrey Mitchell, am directed to inform you that as Dominion Textile and Montreal Cottons strikes are under jurisdiction of and are being dealt with by provincial authorities, minister feels no useful purpose can be accomplished by meeting union delegation as requested.

INVITATION TO PEACE CONFERENCE TO OPEN IN PARIS JULY 29

On the orders of the day:

Right Hon. W. L. MACKENZIE KING (Prime Minister): Mr. Speaker, this morning at half past eleven o'clock His Excellency the Ambassador of France called at the office of the Department of External Affairs and handed the under-secretary of state the following communication addressed to myself. The communication is in French. I shall give to the house a translation, and shall see that a copy of the original also appears in Hansard of to-day:
