Hon. Allan J. MacEachen (Minister of Manpower and Immigration): 1. The "Directory of Canadian Employers" was mailed to 2650 Canadians in post graduate study or research outside Canada.

2. All those in receipt of the directory identified themselves as Canadian citizens.

3. The cost for printing and circulating the booklet was \$3,500.

4. The purpose of the circulation was to assist Canadian students at foreign universities investigate employment opportunities at home. This was to ensure that these highly qualified individuals would have the same opportunity of being considered for vacant positions as Canadian students at home.

5. The program, "Operation Retrieval" is designed to encourage Canadian students abroad to return to Canada upon completion of their studies. My department provides
