PERCENTAGE OF TOTAL FEDERAL TAX REVENUE PAID BY INDIVIDUALS AND CORPORATIONS

Question No. 5-Mr. Broadbent:

What percentage of total federal tax revenue was paid in each year between 1939 and 1970 by (a) individuals (b) corporations?

Hon. Herb Gray (Minister of National Revenue): The federal tax revenues for Customs and Excise and Taxation for the period 1939-1970 are shown in the Department's Annual Reports tabled in the House each year. The revenues collected by the Taxation Division are generally shown separately in the Annual Reports for individuals and corporations. However, import records are not kept in such a way as to provide such separate figures in the case of duties and taxes.
