FEDERAL ASSISTANCE TO LA LIGUE DES DROITS DE
L'HOMME, MONTREAL

Question No. 2,257—**Mr. Hellyer:**

Has "La Ligue des droits de l'homme" of Montreal received any financial assistance from the government since January 1, 1972 under the Local Initiatives Program, the Opportunities for Youth or any other federal program and, if so, on what dates and in what amounts?

Mr. John M. Reid (Parliamentary Secretary to President of the Privy Council): The Local Initiatives Program and the Opportunities for Youth did not make any grant to this project since January 1, 1972. However, the following amounts were given to "La Ligue des droits de l'homme": Secretary of State Department, September 11, 1972, \$10,000; Secretary of State Department, February 13, 1973, \$7,000; Canada Council, March 28, 1973, \$23,000.

NOVA SCOTIA—OFY GRANTS

Question No. 2,269—**Mr. Nowlan:**

By federal constituency in the province of Nova Scotia for the 1973 period (a) how many applications for OFY grants were received (b) how many projects were approved (c) what was the total amount in dollars involved (d) how many man-weeks of employment were generated by the projects approved?

Hon. James Hugh Faulkner (Secretary of State): (a) A list of all projects funded under the 1973 Opportunities for Youth Program has been compiled. Projects are classified by provinces and in alphabetical order of the towns and localities in which projects are being carried out, not by constituency. Information includes the project title and number, a short description of the project's activities, amount of the grant, number of participants and the name and address of the project representative. This listing has been circulated to members of parliament. The number of applications received from the Province of Nova Scotia for OFY grants in 1973 was 549; (b) 260; (c) and (d) \$1,646,509, providing 18,455 man-weeks of employment.
