Mr. MacKay: Mr. Speaker, I rise on a point of order and I will ask you to bear with me for a moment as I do not do this very often. I am quite disturbed at the action taken by the Minister of Transport (Mr. Marchand) in relation to the widely publicized head tax for travellers and the proposed charges under the Aeronautics Act. The minister was in the House yesterday, then he went out and made this announcement. He should have made a statement on this important matter because it involves taxation which, after all, is one of the fundamental reasons for parliament's existence.

I do not intend to go on at any length but I should like to say, through you, that I would respectfully request you to suggest to the minister that he follow what I believe to be the better practice, one which has been followed by custom in this House of Commons, that is, to make announcements of this nature in the House of Commons or at least have the courtesy to do so in committee, instead of leaving the House to make an announcement of such fundamental importance to the newspapers.

Mr. Marchand (Langelier): Mr. Speaker, a bill has been passed by the House three years ago under which the government could levy an airport tax. The only amendment brought in by the Progressive Conservative Party at that moment dealt with levying a fixed rate tax, and that amendment had been brought in by the hon. member for Edmonton West. That bill was passed by the House, and its coming into force has not been proclaimed by the government. The House was then fully aware of that situation, as evidenced, Mr. Speaker, by the fact that the opposition did not even ask me one question about the tax that has been levied.
