REQUEST BY GOLDEN AGE FEDERATION OF QUEBEC FOR INCREASE IN OLD AGE PENSION BENEFITS

Question No. 1,026-Mr. Caouette (Témiscamingue):

Since 1964, has Golden Age Federation of Quebec claimed the increase in old age pension benefits and, if so (a) on what date (b) in what manner (letter, petition, meeting)?

Hon. Marc Lalonde (Minister of National Health and Welfare): The Golden Age Association of Quebec requested that the provision in the legislation which limited the annual increase to OAS pensioners in receipt of the GIS to 2 per cent be amended: (a) May, 1970; (b) By letter supported by a petition. The limit in the annual increase in the pension and the supplement was removed by an amendment to the OAS Act in May 1972. Since then the increases have been in line with the actual rise in the cost of living. Since October 1973, the increases are made in January, April, July and October each year based on actual rises in the cost of living.

WOOD ISLANDS-CARIBOU FERRY SERVICE

Question No. 1,050-Mr. MacLean:

- 1. What plans are underway for increasing the capacity of the Wood Islands-Caribou service in (a) ships (b) terminal construction?
- 2. On what date is it planned that these improvements and additions will be completed?

Hon. Jean Marchand (Minister of Transport): 1. (a) Discussions are currently underway to obtain a fourth vessel for operation in this service during the peak summer period. (b) Construction work is currently underway at both Wood Islands and Caribou which will provide an additional end loading facility at both terminals.

2. (a) If discussions mentioned in 1(a) are fruitful, the fourth vessel should be in operation in June 1975. (b) Completion of the end loading facilities at Wood Islands are scheduled for completion in June 1975. The completion date for the Caribou facilities is July 1975.

GOLDEN AGE PASSPORTS

Question No. 1,093-Mr. Hnatyshyn:

Is it the intention of the government to institute the concept of "Golden Age Passports" as in the United States which are issued without charge to any person 62 years of age or older and entitles the bearer and any person accompanying him or her in a single, private, non-commercial vehicle (a) to enter any designated entrance fee area of the national parks system administered by the department responsible (b) to use any designated special recreation facility provided at any federal outdoor recreation area, excluding those provided by a concessionaire, at the rate of 50 per cent of the established daily special recreation use fee?

Mrs. Iona Campagnolo (Parliamentary Secretary to Minister of National Health and Welfare): It is not our intention to institute such a concept at this time but it is under consideration.

VANCOUVER INTERNATIONAL AIRPORT—BAGGAGE SECURITY

Question No. 1,094-Mr. Reynolds:

- 1. How many Uniguard baggage security people are on duty at the Vancouver International Airport in Richmond, British Columbia?
- 2. What is the monthly cost of this service?
- 3. What is the estimated cost for the year 1975?
- 4. During 1973, how many articles were reported to the airport RCMP as stolen from the baggage ramps?

Hon. Jean Marchand (Minister of Transport): 1. The number of people on duty at any one time varies with need but amounts to a daily requirement for 36 man hours.

- 2 and 3. This cost is an Air Carrier responsibility.
- 4. Twenty-six incidents of loss and theft reported.

CANADIAN REGISTERED AIRCRAFT EQUIPPED WITH PRATT AND WHITNEY JT-8D ENGINES
