#### CANADA ELECTIONS ACT

AMENDMENT TO PROHIBIT PUBLICATION OF OPINION POLLS

Mr. Herb Breau (Gloucester): Mr. Speaker, I have examined this Bill very carefully. It is a very important issue, and I know that the Hon. Member who has had experience in the administration of his Party has had occasion to be concerned by the effects that the publication of public opinion polls can have on elections. I am not so sure that the way to proceed with this nature is by way of legislation at this time. The form by which the Hon.
