### CANADA-FRANCE AGREEMENT

**Mr. John R. Rodriguez (Nickel Belt):** Mr. Speaker, my question is for the Minister of Fisheries and Oceans and deals with the interim agreement that has been signed between the Minister and the Government of France. The Minister would have us believe from all his answers today that this agreement is a fine one. If it is such a fine one, why did the Minister not consult with the Premier of Newfoundland before he signed it?

**Hon. Thomas Siddon (Minister of Fisheries and Oceans):** Mr. Speaker, I did not characterize the agreement as a fine one.

**Some Hon. Members:** Oh, oh!

**Mr. Siddon:** In an issue as difficult as this, sometimes a measured step has to be taken toward a solution. In this case the Government of Newfoundland and the industry were fully involved up until the final occurrence, the final trip to Paris last week. French officials, after reconsidering previous

meetings, decided that there was a possibility of concluding an agreement within the terms of reference and conditions which had been agreed to and were well known to the various Governments prior to that date.

**Mr. Rodriguez:** Mr. Speaker, obviously the French Government thinks it was a fine agreement. The people of Newfoundland are sick and tired of this Minister acting like a French poodle instead of a Labrador retriever.

### ROLE OF NEWFOUNDLAND

**Hon. Thomas Siddon (Minister of Fisheries and Oceans):** Mr. Speaker, I am tempted. I do not know whether I should characterize the Hon. Member as a red snapper or as a fear monger. The fact is that the arrangements under which this agreement was concluded, an agreement which gives nothing away at this point, were fully known to the Province of Newfoundland. My office has been in daily informal contact, and while we can certainly appreciate the basis for Mr. Peckford's reaction we believe that when Newfoundland fishermen have to face a choice between ultimately resolving the boundary question or having this unsatisfactory situation continue, they will weigh the factors and decide to see the boundary issue resolved once and for all.
