GOVERNMENT CONTRACTS

PATRONAGE ALLEGATIONS—RCMP INVESTIGATION

Hon. Bob Kaplan (York Centre): Mr. Speaker, my question is for the Deputy Prime Minister and it concerns the Prime Minister's apparent double standard of political morality shown over the weekend. The Member of Parliament for Rosemont is kicked out of the Tory Caucus for what the Prime Minister called irresponsible and unacceptable behaviour. She is on the side of—

Mr. Speaker: Just a moment. The Hon. Member may be rising on a matter of considerable political interest, and there certainly may be other places to pursue it, but I am having some difficulty here because, as Hon. Members know, a question directed to the administration has to deal with the administration of government. So far the Hon. Member is not persuading me that that question does involve the administration of government. Perhaps the Hon. Member can help the Chair.

Mr. Kaplan: Mr. Speaker, I can assure you that I believe the question I will ask does comply with the rules of the House, but in the preamble I wanted to raise circumstances which have been much in the news over the weekend and which

reflect on the political morality of this Government as a Government.

I contrast the treatment of the Member for Rosemont with the Member of Parliament for Gamelin who faces 50 charges of influence peddling, and yet he remains in caucus.

Mr. Speaker: I have asked the Hon. Member, who is an experienced Member, to assist the Chair and stay within the bounds. I do not want to interrupt a lead question, and I do so with great hesitancy. However, I do ask the Hon. Member's co-operation.

Mr. Kaplan: Mr. Speaker, I wanted also to contrast that with the Member for York—Peel who, after having 14 violations—

Mr. Speaker: The difficulty the Chair is in is that the rules by which we are bound are designed ultimately and primarily so that questions do not create disorder and, second, that they be pertinent to the administration of the Government. The Hon. Member, I know, understands this, and I would ask him to put his question. Otherwise, I may have to move on to another Member.

Mr. Kaplan: Mr. Speaker, the Prime Minister's condemnation of the MP for Rosemont is based on an RCMP press release which I have here which says simply that she had no evidence to justify initiating a criminal investigation. Whether she had anything new to add on that day, August 19, we all know she has evidence of alleged kick-backs because she is a key witness for the prosecution against the MP for Gamelin.
