INTEREST RATES - CALL FOR REDUCTION

Mr. Lorne Nystrom (Yorkton—Melville): Mr. Speaker, I am sure you are aware that this country is now in the midst of an interest rate crisis, a crisis that will affect not only the farmers, workers, and small business community, but also people who want to buy homes.

You might recall, Mr. Speaker, that back in 1981 the Conservative Party was howling and complaining in the House about interest rates being much too high. At that time, the real interest rate in Canada was around 6 per cent. Now the real interest rate—the difference between the bank rate and the cost of living—is around 8 per cent, not 6 per cent. It is some 2 per cent higher.

In 1981 the present Minister of Finance (Mr. Wilson) and the present Secretary of State for External Affairs (Mr. Clark) were saying that interest rates were too high, they ought to be brought down, and that there ought to be a new Government to bring them down.

I now call upon the Government across the way to stop hiding behind John Crow and the Bank of Canada, and to bring down interest rates in order that the ordinary people in this country have a fair deal.
