Groups such as the Canadian Renewable Fuel Association have pointed out that vehicle conversion to other forms of fuel, such as natural gas, propane and ethanol are clean and financially viable alternatives to gasolines.

The U.S. Congress is currently debating amendments to the Clean Air Act which addresses the issue of emission levels. This act will implement sweeping environmental standards far exceeding anything that we have in Canada. This government must stop posturing on environmental issues and start to encourage the use of cleaner fuels in the millions of vehicles on the road in Canada.

I have already mentioned in the House the need for the government to grant financial support to the poorer families, including a salary to homemakers. I urge again the government to seriously consider the possibility of granting a salary to homemakers, especially in the case of the poorest families.

CANADIAN ARMED FORCES

The waste included such items as boxes of T-bone steaks, prime smoked beef and canned foods, all in extremely large quantities; batteries and equipment still in its plastic wrappers. OFFICIAL LANGUAGES ACT

Mr. Jean-Robert Gauthier (Ottawa-Vanier): On April 11, 1989, Mr. Speaker, the President of Treasury Board promised the House that the government would table before the end of 1989 the regulations concerning the Official Languages Act. Nineteen months have elapsed since Bill C-72, an Act respecting the status and use of official languages in Canada, was adopted on July 7, 1988, and over nine months have elapsed since the President of Treasury Board promised the House to table the said regulations.

Including its public consultations and the study by the Standing Joint Committee on Official Languages, the government will have needed three years before taking action.

I am flabbergasted by this Tory Government's irresponsibility in this area. Having failed to deliver, the President should at least try to save face by tabling immediately and in its entirety the draft regulations with respect to the Official Languages Act, so that Canadians may know what direction where the government stands as far as its official languages policy is concerned.
