2. Bill (No. 158) an Act respecting the London and Lake Huron Railway Company, (all Rules and Orders suspended). Bill passed through all stages: Mr. Lister, 462. Passed by Senate, 544. Royal Assent, 612.—61 Victoria, Chapter 72.

Read second time; considered in Committee of the Whole; progress reported, 168. Again considered; reported with amendments; considered as amended, 172. Motion for third reading; Bill re-committed; in Committee; Committee rose without reporting, 196. Motion to place Bill again on the Orders of the Day; negatived, 202.
