

DISTRICT BODY TO BE ORGANIZED

The Retail Hardware Dealers of Western Ontario Likely to Form Association.

A deputation consisting of President Scott, Executive Member Brookbank and Secretary Wrigley, of the Ontario Association, visited this city on Wednesday, and had a conference with representatives of the London Retail Hardware Association. Plans to make the provincial and local associations of greater benefit to the trade were discussed, and at the next meeting of the local association it is probable that arrangements will be made for all of the London dealers to join the provincial association.

Mr. Alex. Purdon, of the Purdon-Gillespie Company, and Messrs. Tailors and Taylor, members of the London association, expressed themselves as pleased with the work which had already been accomplished by the Ontario Retail Hardware Association, and considered that the organization could be made the means of greatly improving the conditions surrounding the trade in all parts of the Province.

The matter of organizing a large Western Ontario District Association with headquarters in this city, and taking in not only the hardwaremen but general merchants who carry stocks of hardware, was discussed and favorably considered.

In St. Thomas every hardware dealer is already enrolled in the Ontario Association, and with a little work on the part of an organizer the whole district, with London as a center, could be organized on an effective basis, which would eliminate such evils as jobbers selling to consumers and promiscuous price-cutting.

NIAGARA POWER SUPPLY OFFER

American Company Offers It for Kingston and Other Eastern Points.

Toronto, May 18.—At a meeting of the hydro-electric power commission yesterday an offer was received from the New York and Ontario Power Company for a supply of electrical energy which would serve Kingston and many points from there eastward. The company has a plant at Waddington on the New York side of the St. Lawrence River capable of producing about 33,000-horsepower, and they have received permission from the New York State authorities to export to the Canadian side. Up to the present the commission has not received any formal applications for power from this source.

The commission has also received from the town of Port Arthur a request for 3,000-horsepower of electrical energy. Negotiations are, it is understood, now in progress between the commission and private concerns whereby it is hoped this can be supplied to the municipality almost immediately at satisfactory rates.

On Monday a conference of solicitors will be held here prior to the meeting of the Western Ontario Municipalities Niagara Power Union, which will be held on Tuesday at the city hall. Mr. A. F. Lobb, for the commission; Mr. T. G. Meredith, of London, Mr. S. H. Blake, for the Ontario Power Company, and Corporation Counsel Puller, will take part. Mr. Meredith on this occasion will act for the Government. The proposed contract between the commission and the power company named for the supply of power at the Falls will be carefully scrutinized, as will also the form of the proposed formal contracts between the municipalities and the commission on the following day these and other matters will be discussed by the power union meeting, which will commence in the city hall at 11 o'clock, and close with a dinner at the Parliament buildings at 7 o'clock.

New York, May 18.—Mrs. Catherine Wallis Dureya, known at the time of her marriage to William Dureya, jun., son of the late starch manufacturer, a prettiest girl in Glenview, Ill., will lose her share of her late father-in-law's \$750,000 estate by marrying a young preacher.

Her father-in-law's will, just admitted to probate, leaves her \$150,000 outright if she remains single, and more than \$100,000 at the death of his wife, if she still has not taken a husband. She gets practically nothing if she weds.

Regardless of the will, she is to marry the Rev. Mr. Dureya, a young man of 25, who recently graduated from Princeton University, and who at present is teacher of languages in the Harvard Theological Seminary.

She met the minister at Clifton Springs, where they were engaged in a part of last winter in search of health. They fell in love, much to the annoyance of her father-in-law, who was a wealthy man. Mrs. Walker Dureya will not only give up her fortune, but will permanently sever ties with her father-in-law's estate.

Mr. Angus will not say whether or not he will marry her, but he has planned to be married yesterday, but the death of Mrs. Dureya, died on Sunday. His funeral took place Tuesday. The day that the wedding was to have taken place. The Rev. Mr. Angus was told today that under the will of his father-in-law he would forfeit her share of the estate if she married.

"We knew all well the provisions of Mr. Dureya's will," said he, "and it does not make a particle of difference in our plans. We have made her decision, and she will not change it because of marrying me she loses the money that would come to her from her father-in-law's estate."

CIVIL SERVICE ASSOCIATION.

Ottawa, May 18.—The Civil Service Association, the newly-formed union of Government employees, will receive a provisional constitution on Monday and meet on Tuesday to elect officers and formulate a statement to be laid before the civil service commission early. The new association will admit only Ottawa workers.

DISPLEASED WITH WINDSOR.

Windsor, May 18.—H. H. Gore, of Detroit, promoter of the Twentieth Century Transportation Company, is not pleased with the treatment his company has received from the Windsor City Council regarding a ferry franchise. He says his company offered to put up a guarantee of \$5,000 and to pay the city \$1,000 per year for a franchise. So far, however, the council has taken no action on the proposition, and apparently does not wish to treat with the new company.

BLOODSHED IN NEW YORK STRIKE

Detective, Pursued by a Mob, Shoots and Kills Innocent Bystander.

New York, May 17.—A fatal shooting and an attempt to lynch the man who fired the shot marked the strike of longshoremen in Hoboken today.

The man who lost his life was an innocent bystander, Harry Marshall. He was struck by a bullet fired by Benjamin Vincent, a private detective, who had been employed on one of the docks affected by the strike. Vincent shot at some strikers with whom he had quarreled and by whom he was being pursued.

The trouble began when Vincent entered a saloon near the docks and asked for a drink. As the bartender asked the bottle to him one of several striking longshoremen, who were in the saloon, shouted: "Don't give it to him; he's a scab."

Vincent denied the charge, but the bartender refused to serve him. Just what happened then is not known, but a moment later Vincent dashed into the street, with a revolver in his hand and a crowd of strikers at his heels.

As he reached the street he turned and fired. Marshall was standing on the sidewalk and the second bullet from Vincent's revolver struck him in the head and killed him instantly.

When Marshall dropped to the sidewalk the strikers started toward Vincent with cries of "Lynch him, lynch him." Vincent opened down the street, with the revolver still clutched in his hand, and the angry crowd only a few feet behind him.

BISHOPS CONDEMN CONGO HORRORS

The Primate of England Urges Steps Toward Immediate Reform.

London, May 18.—The subject of Congo misrule was discussed yesterday in the Upper House of Convocation of Canterbury, the primate presiding. A series of resolutions were passed, expressing profound regret and indignation at the methods of administration in the Congo Free State, declaring that the members of that house felt keenly the burden that was cast upon the conscience of England, as one of the powers by whose consent the Congo Free State was established and its neutrality guaranteed, and stating that the gravest responsibility will lie upon the consenting powers to bring to an end, in some way, abuses which are so crying, and which may be of the most sinister effect upon the relations between white and colored races throughout the world.

The Bishop of Southwark, in introducing the subject, said the Congo State began on commercial, philanthropic and civilizing principles. The British Government and considerable responsibility for it, and there was ample evidence that things had gone significantly ill.

Dr. Talbot went on to allude to the suppression of the evidence of the royal commission, and directed attention to the fact that in Mr. J. L. Gore's book on "Red Rubber: The Story of the Slave Trade on the Congo." No doubt a condition the most barbarous and terrible existed. To get a certain amount of rubber out of the poor natives, the most horrible methods had been resorted to, such as cutting off the hands, and other further gross system of hostages, these hostages being largely women. No responsibility rested upon Belgium itself in the matter. If all the powers were keen about it, a very summary result, he said, could be obtained.

The Free Church Council, to their honor, had been far before the Church of England in trying to arouse public attention, but this might be partly explained by the existence of so many Baptist missionary stations, from which information came.

The Bishop of Birmingham spoke in general support of what had fallen from the Bishop of Southwark, and the Bishop of London pleaded for increased British consular representation in the Congo Free State. They ought to be prepared to back up the Government in any further step which they might wish to take with the view to wiping away this abomination from the face of the earth.

The primate, in summing up the debate, said the House had discharged an imperative duty in calling attention to the facts of the case. In the last decade we seemed to have fallen into something which rivaled, if it did not exceed, the horrors of the old slave trade. He could not suggest what diplomatic action should be taken, but they desired the country to know that they were not indifferent to the matter, and they did not intend to let it alone.

YANKEES CROWD OLD LONDON TOWN

Vast Numbers of Tourists From America Delight in English Sights.

London, May 18.—London is fast filling with Americans. They are arriving by every train, filling the hotels and boarding houses and keeping the hirsers of motor cars busy with orders. From the continent there is almost as much travel as there is from America. The two streams meet now in the city, and the wealthy half-European-American who has been spending the winter on the shores of the Mediterranean is home-bound.

The often wealthier American who keeps an automobile in the winter has no time for idling in the winter, rushing over to take a couple of weeks or a month of rest and recreation in England.

With all classes of visiting Americans the theater is the passion of the moment. Not an evening is allowed to pass without a visit to one of the popular plays now running in London. They grumble a good deal at the prices asked for the stalls. But they will take no other seats than the stalls, liking to be in a position in which they get a view of the house, as well as of the stage. Many of the men complain, too, at the custom which compels them to wear evening dress. They prefer for themselves and their wives the simpler habit of New York or Paris.

Many of the weather visitors are bringing their motor cars with them. Many millionaires, by the way, now keep a car or two on this side of the Atlantic all the year round. Whether wealthy or not, the visiting American does not feel that he has seen England unless he has taken a run down to Shakespeare's country or into Devonshire on an automobile.

"The automobile," said Mr. Flagg, the London manager of the American Express Company, in whose Haymarket rendezvous Americans foregather, is helping to keep Americans in this country. Where formerly they would stay a day or two in London and then go at once to Paris, they are now spending the best part of their holiday in touring England by car. We encourage them to do it, planning tours for them by automobile and putting them in the way of seeing the most beautiful and interesting parts of this country without trouble."

Staying at London hotels at the moment are many Americans whose names are household words on the other side. Judge Morrow, of California, who is staying at the Savoy, has been making a holiday study of the system in English courts, and admires the greater rapidity of English methods, especially in criminal procedure. Senator Schumann, of Boston, is another distinguished American who is stopping at the Savoy.

YANKS BANQUET JAPS

Prominent New Yorkers Honor Kuroki and His Party.

New York, May 17.—The entertainment of the Japanese army and navy officers now in New York reached its climax tonight in a banquet given in the grand ballroom of the Hotel Astor by prominent citizens of the city.

The official guests of honor were Viscount Aoki, Japanese ambassador to the United States; Gen. Baron Kuroki, of the Mikado's army; Vice-Admiral Ijima, of his majesty's navy; the members of Gen. Kuroki's staff and the officers of the Japanese cruisers Tsukuba and Chitose.

Admiral George Dewey, the ranking officer of the United States navy, presided. The great ballroom was lavishly decorated with palms and cut flowers, and everywhere the flags of the two nations, the Stars and Stripes of the United States and the Rising Sun of Japan. The military and naval officers present, as well as the foreign diplomats, appeared in full uniform, adding a touch of color to the scene, which was accentuated by the costumes of the women who were present.

There were a number of speakers at the banquet, including Oscar S. Strauss, secretary of commerce and labor, who represented the federal government; Secretary Strauss, after describing the ties of friendship binding Japan to this country, declared that the Japanese were too wise to permit the San Francisco school incident, which was fostered "by ignorance and propagated by injustice," to cloud their just appreciation of the enlightened spirit of American institutions.

Montreal, Que., May 18.—George Gillespie, of Gillespie & Co., wholesale merchants, died this morning at the Royal Victoria Hospital after an illness, from a complication of causes, extending over several weeks. He was widely known in the business community and popular with his fellow-men. He was 57 years of age.

KING ANGRY AT "MIKADO" FUSS

Prohibition of Play First Amused Then Made the Public Indignant.

London, May 18.—King Edward is said to be very angry at the clouds of dust that have been raised over "The Mikado" during his absence, and he has certainly made the lord chamberlain and the home secretary, Mr. Gladstone, look not a little foolish.

The lord chamberlain's order that the popular comic opera was to be struck off the lists of licensed plays prior to the visit of Prince Fushimi and never again to be rescored, out of respect to the feelings of the Japanese allies of Great Britain, was received first by the public with incredulity, followed by amusement, that giving place to intense indignation. But it is not likely that the opera will be shelved forever, though the lord chamberlain will be permitted time to climb down gently instead of coming a cropper. Humpty Dumpty, indeed.

King Edward was not long home before he interposed, which, I am told, resulted in the first step in the climb down when Mr. Gladstone announced in the House of Commons that "The Mikado" would be revised with a view to the present restriction being removed.

This is not the first time the King has returned from abroad to set right a matter on which there was a great public outcry. When the agitation in the Beck case was at its height his majesty was away from home. He called for the home secretary, and immediately on his return, and the result was that the very next day a royal commission of inquiry was appointed. The same is true with regard to the Edalji cattle-matting case.

King Edward has, in fact, been very much annoyed at the ridiculous manner in which "The Mikado" affair has been conducted. It is true, in spite of official denials, that high Japanese authorities were greatly concerned at the revival of "The Mikado" at the Savoy Theatre, practically coinciding with the visit of Prince Fushimi. The representations on the matter were made to the Government, resulting in a storm of dust and satirical comment on the part of the continental press.

There would not have been the slightest difficulty had Mrs. D'Oyly Carte been approached and the situation explained to her. The revival would have been delayed and the provincial performances would have been stopped temporarily without any explanation to the public. There would have been no fuss.

As it is, the very thing it was desired to avoid—the ridiculous manner in which "The Mikado" affair has been conducted—the public notice during the visit of Prince Fushimi—has been aggravated to an extravagant extent. This it is which has made the King so angry.

His suggestion, and I am assured that this is the case, that the theatre should be closed, and the play be made where necessary in the text, will quickly bring the matter to a close. With the alterations made the new version of "The Mikado" will be shortly put on at the Savoy, when it is safe to say, a big boom awaits it.

STOCK MARKET.

New York, May 18.—The bank statement showed an increase in surplus in specie and a decrease in loans, though of small proportions for the latter item. Money seems to be moving towards this center from the interior generally, except the special requirements of San Francisco for shipment of goods.

From week to week now not only that they are keeping up, but that the volume is increasing. The list of market declines today, and the wheat situation, gold exports and the lack of public sentiment have helped the professional bear party. There is absolutely nothing doing in the bond market, except some activity in the new Union Pacific bonds, which broke 30 in sales today. The stock market closed down from one to two points, and showed very little life or buying power at any time during the day. Sentiment has shifted from stocks and bonds into the other markets.

Chicago, May 18.—Wheat—The 4 to 5 per cent decline was due entirely to profit-taking, which exceeded the volume of the buying throughout the session. That the market was not going up constantly need not discourage any trader. The reasons make the market healthy, and give opportunity for reinstatement of lines and for new buyers to take hold. Foreign markets generally were lower on profit-taking preceding the holidays on Monday and Tuesday, and on reports of ruin in Hungary, which seems confirmed by the 60 decline at Budapest. Liverpool closed a shade higher. Receipts were 62 cars, with 48 expected on Monday.

Corn broke to a level on realizing induced by the weakness in wheat and by some indication of a free movement within the next ten days. Receipts were lighter than expected, at 116 cars, with 130 looked for on Monday.

Oats sold off in common with other grains, but exhibited a stubborn resistance at the decline. There were a number of complaints here from Iowa of dry weather and of bugs in the fields in parts of Nebraska. Estimated for Monday, 136 cars. Winnipeg closed: Wheat—July, 97½c; October, 92c.

CHICAGO EXCHANGE.
