#### NATIONAL DEFENCE

NORAD—SUGGESTION COMMUNICATIONS BETWEEN CANADA AND UNITED STATES BE IMPROVED—MOTION UNDER S.O. 43

Mr. Bob Wenman (Fraser Valley West): Mr. Speaker, I rise under the provisions of Standing Order 43 regarding a matter of urgent and pressing necessity. In view of the fact that the United States and, presumably, the joint Canada-U.S. NORAD command centre knew in early December that there was a nuclear-powered cell aboard a malfunctioning Soviet satellite, and in view of the fact that the Prime Minister has been unable to explain why the Minister of National Defence did not receive this information until last week, and this information was withheld from the Prime Minister in spite of the fact that he skied into NORAD headquarters for his supposedly more than comprehensive briefing, I move, seconded by the hon. member for Victoria (Mr. McKinnon):

That this government take measures to improve communications between the Canadian command and the Prime Minister before another crisis occurs.
