Mr. Marchand (Langelier): Mr. Speaker, there is no discrimination at all in respect of these plans.

Mr. MacInnis: Mr. Speaker, I should like to ask the minister whether he does not consider it discrimination in respect of a man who, years service, is arbitrarily after 49 dismissed?

Mr. Marchand (Langelier): These are isolated cases.

Mr. MacInnis: Would the minister reply to my last question?

Mr. Barry Mather (Surrey): Mr. Speaker, I should like to direct my question regarding traffic safety-

Mr. Speaker: I understand the hon. member for Cape Breton-East Richmond is rising on a point of order. Perhaps the hon. member for Surrey would defer his question.
