Honorable Sir,

Permit me, Sir, to express my appreciation for the copy of your report No. 2290, which you were kind enough to have sent to me.

This report speaks of a very extensive survey that has been made by your committee in regard to the communistic activities in the U.S.A. The findings of the Committee, as given in your report, should prove to be of great value to your country, as well as to other countries, in facing and combatting the advance and spread of the doctrines of the Third International. Although some countries may find the immediate attack focussed on them more than on others, it is no secret that all countries will be subject to the attack of the communists sooner or later. The apostles of this movement are not speaking in strictly national and geographical terms, but always of the world. Against the whole world they are fighting, and the whole world system they are attacking. They speak of world revolution along communistic lines and of the dictatorship of the proletariat of the whole world as their final aim.

These are not empty words. They mean it, <sup>too</sup> and your report proves it. They have not wasted time and energy to prepare for this final aim in the U.S.A., as your report shows in comparing the growth of the communistic organization. The comparison with the accomplishments of any other organization for that length of time shows that this movement is enormous. Its further growth can be checked temporarily, and that only, providing the recommendations of your Committee are followed and proper legislation enacted. But will that be enough?

A further very valuable feature of the report is your definition of communism and your description of the characteristics of the Third International. It leaves no room for doubt of any kind that this movement will make concessions to anybody. It will not do it, and it will not have to do it, providing they can go on with the completion of their Five-Year program in Russia. They will not arbitrate. Their program is known, and from their activities it should be known by now that anybody who is not 100% communist and with them is regarded as their enemy and must face destruction.

From your investigation you will know that for the time being at least the population of Russia, who are kept on the verge of starvation and misery, will not benefit from the huge factories built under the Five-Year plan; the excuse some industrialists are using for dealing with the Soviets and in assisting in the erection of factories and in supplying the Soviets with tractors. The output of the lumber camps, factories, various mines, collective farms, etc. is meant for the destruction of the present world market system. Clearly enough this has been pointed out on various occasions, and again by M. Kaganovich, Assistant Secretary of the Communist party, in the presence of Stalin, Molotoff, Voroshiloff at a huge meeting of young Russians held in Moscow on February 7th last in his following remark: "When we began the Five-Year Plan they said abroad that it was a joke. Now they have stopped laughing and soon it will make them weep". And indeed the world here has stopped laughing.

Despite of knowing this and despite of knowing that the monster factories they are assisting to build and to finance today in Russia are meant for the purpose of crushing the present world system, a number of irresponsible financiers and industrialists are continuing to finance them and to deal with the Soviets.
