perhaps permitted a rather more balanced view of its economic variety. International economic welfare dictates that we should resist excessive nationalistic measures whether they relate to investment or trade. But common sense tells us that economically nationalist measures will continue to exist. The challenge is to understand the different national circumstances that are the basis for our policies and to work together to define generally accepted norms to keep economic nationalism under control.
