Is the government giving consideration to increasing the amount of the CBC grant to meet its budgetary needs as a result of the restrictions on advertising imposed on CBC television and radio licences by CRTC and, if so, for what reason?

Hon. James Hugh Faulkner (Secretary of State): The report of the CRTC includes proposed conditions of licence only for the CBC. It is not yet certain that the proposed conditions will pertain. Should reduced involvement in advertising be attached as a condition of licence and should the CBC agree that this would not impede unreasonably the provision of national broadcasting service, it would appear that increased appropriations would be required to maintain the amount of and high quality of current CBC programming.
