I have said many times that Dr. Boggs' contribution not only to the National Gallery but to the cultural life of this country has been exceptional. It has been at the very highest level. I think the legacy of Dr. Boggs is found in the gallery today in the level of curators and research staff we have there as well as the obvious thrust toward the purchase of Canadian art. Everyone in the government, and on the other side as well, would, I am sure, want to join with me in saying that she has made a marvellous contribution to Canada.

**Mr.** Faulkner: I can also confess that certain efforts were made to try to make her stay.

On the question of a successor, Mr. Speaker, a search committee has been formed and the decision by the chairman of the board of trustees is to make that search as wide as possible to cover all areas of interest in the gallery artists through museum directors, etc. It will be a wide comprehensive search with the fullest possible participation.

# VETERANS AFFAIRS

#### GOVERNMENT MEASURES TO ENSURE SERVICE TO VETERANS IN BRITISH COLUMBIA IN VIEW OF POSSIBLE STRIKE OF HOSPITAL WORKERS

**Mr. Bill Clarke (Vancouver Quadra):** Mr. Speaker, my question is directed to the Minister of Veterans Affairs. Fortunately, the action taken by the British Columbia government yesterday has given a 21-day cooling off period but I should like to ask the minister what plans the government has to guarantee uninterrupted service to the hundreds of war veterans in hospitals in Vancouver in view of the prolonged hospital workers' strike in that province which has spread to seven of the hospitals in greater Vancouver?

Hon. Daniel J. MacDonald (Minister of Veterans Affairs): Mr. Speaker, we have had no problem in British Columbia or many other provinces up to this time. In the past when we have had interruptions as a result of profes-[Mr. Faulkner.] sional people going on strike, sufficient people have usually been retained by law to look after our veteran patients.

**Mr. Clarke:** A supplementary question, Mr. Speaker. I appreciate the minister's concern and I should like to ask if he will ensure—even though they have had no problem until now—that the service will continue uninterrupted in the event of the resumption of this strike?

**Mr. MacDonald (Cardigan):** Mr. Speaker, we are always very close to the situation. When our transfers are completed there is always a guarantee in there for care of patients. We have people situated in those hospitals who are responsible for the care of veterans. I can assure the hon. member that my department will be checking this. As of today, we will look into the situation.

#### POSSIBILITY OF MERGING OFFICES WITH MANPOWER CENTRES—GOVERNMENT POSITION
