Therefore, the three bills which I feel are most urgent are those which I have just mentioned for this week, and next week if it is possible we shall look into the banking legislation.

Mr. Knowles: Madam Speaker, I should just like to be sure with respect to the order of the first three bills. The order as the minister has just given varies slightly, according to my notes, from what we were told at a meeting a day or two ago. We were told then that the first item would be the bill on immigration, that the second would be the bill with respect to the employment tax credit and that the third would have to do with small business. I take it the minister has altered that order slightly. It is now first, immigration, second, small business, and third, employment tax credit.

Mr. Pinard: It is correct that I have just said that. The reason is that the bill concerning the employment tax credit cannot be introduced in the House before this debate is interrupted. Consequently it will be introduced tomorrow for first reading. I would need unanimous consent to proceed with the second reading of that bill tomorrow if we have finished dealing with Bill C-2. So what I told the hon. member still stands. If possible, it will be Bill C-2, the employment tax credit, and then the small business loans bill. But it may happen that we have to deal with small business loans if tomorrow, by any chance, we have finished with Bill C-2. If the hon. member wishes a further explanation, I am available.

Mr. Knowles: The more things change, the more they are the same!

MAIN ESTIMATES, 1979-80

Since some items were paid under the authority of a special warrant, specific reference to this effect will be included in the next appropriation bill.

Mr. Stevens: Madam Speaker, in this connection I was wondering whether the President of the Treasury Board (Mr. Johnston) would confirm that he intends to make a statement on motions later this afternoon touching on what he is now tabling. I might say, also, that I should like to reserve for further consideration a question of privilege having to do with what is being tabled, especially in the context of the statement which was read to the House last night by the Minister of Finance (Mr. MacEachen).
