## REGIONAL INDUSTRIAL EXPANSION

GRANTS TO MAGNA INTERNATIONAL

Mr. Dave Dingwall (Cape Breton—East Richmond): Mr. Speaker, my question is for the Minister of Regional Industrial Expansion. Last night we learned that Magna International received unpublished grants for its operations in Markham, Ontario. We also learned that Peter Czapka, son of Tony Czapka runs two of those Magna plants. Would the Minister explain to the House how he can continue to perform his duties as Minister of the Crown when these obvious links between his private holdings and those of his public responsibilities have now been exposed?

Hon. Sinclair Stevens (Minister of Regional Industrial Expansion): Mr. Speaker, the Hon. Member has referred to certain transactions occurring, I believe he said, in Markham. He perhaps hasn't consulted with his leader. Certainly as Prime Minister the leader would have known those were Liberal transactions in the Memorandum of Understanding signed on August 27 and specifically referred in Annex One to that agreement.

## ABSENCE OF PRESS RELEASES

Mr. Dave Dingwall (Cape Breton—East Richmond): Mr. Speaker, my supplementary question is for the same Minister. In view of the fact he was the Minister who approved that, would he explain in the House, because Members on this side do not want to use the term cover-up, why no news releases were issued with regard to those grants? Does the Minister have something to hide from the Canadian people? Why does he not come clean and tell us the whole story, the complete story?

Hon. Sinclair Stevens (Minister of Regional Industrial Expansion): Mr. Speaker, perhaps the Hon. Member should be enquiring of his leader or possibly Ed Lumley. Ed Lumley signed the Memorandum of Understanding on August 27, 1984. It contemplated \$50 million worth of transactions with Magna International, including the three Markham deals. They are itemized. For example, there is deal No. 207, 834 for hinges, the Multimatic deal. In truth they should answer to the House why no press release was issued with respect to the original memorandum of understanding.
