National Secretary Present To Assist in Organization.

A large co-operative council for the carrying on of girls' work in the city was formed last evening at a banquet held in the Y. M. C. A. dining-hall for the purpose of bringing girl workers together and forming some such plan of co-operative endeavor. This meeting was called by the local Y. W. C. A. There were as many as 75 representative women and girls from the various Protestant churches in the city, and several clergymen present. On motion of Miss McCamus, Y. W. C. A. convener of girls' work, who was partly responsible for the calling of the meeting, the gathering formed itself into a council, two representatives from each of the Protestant churches in the city becoming members. arrying on of girls' work in the city

Executive Appointed.

On further motion of Mrs. C. Foreman, a nominating committee was named, which withdrew and appointed a permanent executive, with power to carry on girls' work in the city and elect their own officers. Those elected to this executive are as follows: Miss McCamus and Miss d'Avignon, representing the Y. W. C. A.; Mrs. Aiken, Mrs. Goodwin and Mrs. McIntosh, representing the Presbyterian Church; Mrs. Tutt, Mrs. Wilson and Miss Helen Tufts, representing the Methodist Church; Mrs. Foreman, Mrs Betts and Mrs. Armitage, representing the Anglican Church; Miss McCallum, Miss Burtch and Miss McDermid, representing the Baptist Church, and Mrs. W. Claris, Mrs. Linton and Miss Tapscott, representing the Congregational Church. The suggestion was made that Miss d'Avignon, Y. W. C. A. girls' worker, be appointed secretary to this executive.

It was suggested by Miss Winifred Thomas, national girls' work secretary, who was present and spoke to the meeting, that every clergyman and Sunday school superintendent in the Protestant churches be considered a member ex-officio of the large co-operative council, and feel free to attend their conferences. It was further suggested by her that each denomination gested by her that each denomination officially appoint one minister and one Sunday school superintendent to stand on this council, whose duty it would be to attend the meetings.

Girls' Work.

Miss Winifred Thomas addressed the meeting, outlining girls' work as it is now being carried on successfully in many cities' throughout Canada.

"Girls' work is carried on among girls from 12 to 17 years of age," she declared. "The alm of a girls' work council should be to get in touch with every girl of this age in the Protestant denominations, whether she be in school, in church, in the country, in the city, or at work, and provide for the city, or at work, and provide fo these girls an adequate program, such as that known as the 'Canadian Girls-in Training Program.' This program aims at developing the girl, physically, spiritually, mentally and socially, and links up the Sunday school with a mid-week activity."

Most Critical Period.
Miss Thomas pointed out how the girl between 12 and 17 was passing through the most critical period of her life, when she could be most easily influenced, and how necessary it was for the churches to seize this opportune time for making a definite impression on her. She felt that the only way to obtain the best results was through the co-operation of all the various churches, telling how the larger Protestant de-nominations had realized this five years ago, when they formed a national ad-visory committee for girls' work in Canada, and drew up the "Canadian Girls



WESTERN MEDICAL **SCHOOL OPENS WITH** LARGE ENROLLMENT

Over Thirty War Veterans Are Taking Course.

With a Freshman enrollment unprecedented, Western University Medical School opened its doors this morning, and lectures to all classes were begun today. About 31 former members of the Canadian expeditionary force have enrolled for the five-year course, which enrolled for the five-year course, which is for veterans only, and 16 candidates signed up for the six-year course in medicine which was inaugurated at the Western this year. In addition to the above recruits, the regular classes are in session, and several embryo doctors from other Canadian universities have entered the medical school here to complete the course.

Space Is Scarce.

The Faculty of Medicine at Western is laboring under a handicap with the heavy enrollment, space being at a premium. The five-year group of Freshmen will be divided into two classes, alternating the time table, while a great deal of the study for the six-year men will be in the Western University arts building, as several subjects have been added to the curriculum, making the first year course a preliminary to medicine.

The officials at Western are in hopes that when registration takes place next fall the new medical school, for which debentures have been issued, will be ready for occupation, or failing this, that it will be partially completed in order to accommodate a few students, and thus relieve the congestion. The new building will be located on the site purchased at Waterloo street and Ottaway avenue, and in the meantime the chemical laboratory at the Institute of Public Health has been enlarged to accommodate 24 Freshmen Meds.

Temporary Laboratory.

A temporary physics laboratory has also been fitted for first year medical classes at the art building of Western. The attendance this year for the medical classes has exceeded all expectations, making a record in the school, and geveral additions have been made to the faculty in order to insure a high standard of efficiency for Western University Medical School.

With Justice Kelly presiding, the fall assizes of the supreme court for Middlesex County opened in the county courthouse yesterday afternoon at 1:30 o'clock. The grand jury was empanelled and addressed by the judge. He explained the duties of the jury, especially in regard to the one criminal case of the session, the crown's evidence of which they were to consider. The criminal charge, made against Benjamin West of London Township, was that of indecent assault upon a young girl. The jurymen then left the courtroom, and after over an hours absence, returned to deliver their decision of a true bill. So West will be tried during the January assizes.

Mr. Justice Kelly, before adjourning the court, advised the members of the grand jury to make the usual tour of inspection of the jail, the Ontario Hospital and other public buildings. He sales heard appeals for naturalization papers from several foreigners.

Speaking to the grand jury members, Justice Kelly stated that there were 18 prisoners in the local jail at present, and of that number 14 are serving time and four are on remand. "It is a significant thing," he said, "that 8 prisoners out of the 18 have been imprisoned for being drunk or for breach of the Ontario temperance act. I wisn to draw the jurymen's attention to the fact that the O. T. A. is either not being enforced or cannot be enforced." In regard to the criminal evidence to be regard to the criminal evidence to be considered, he stated that men in this province have always prided themselves on their manhood. There have been too many offences against women in the past, and the fact that they have not been entirely stopped is a reflection against the manhood of Ontario.

EIGHTEEN MONTHS IN JAIL FOR STEALING

Henry Kaltenbach May Go To Reformatory.

Henry Kaltenbach, who pleaded guilty a week ago to stealing \$800 worth of furs, rugs and jewelry from the residence of R. G. Fisher, 90 Albert street, on August 8, was sentenced by Magistrate A. H. M. Graydon this morning to serve eighteen months in the common iail.

"I wasn't in my right senses when it was done," said the prisoner when asked if he had anything to say.

Mr. Fisher, the magistrate remarked, had made representation on behalf of the prisoner, and for that reason he was going to mete out a comparatively short term. If there had been actual housebreaking, Kaltenbach would have been liable to a life term. As it was, the maximum penalty for his offence was fourteen years in penitentiary. A man who would enter a house and steal after nightfall was dangerous, it was said.

However, Kaltenbach had assisted the police to recover most of the goods, which were peddled in Toronto and Hamilton.
