We have had consultations, and I believe there is agreement among the representatives of the parties that I put a motion at this time, under motions, to dispose of a number of items of business, not to pass them but to arrange that they be dealt with in a later

session. I move, seconded by the Minister of Finance (Mr. Macdonald):

That the Standing Orders be amended by adding, for the remainder of the present parliament, the following:

117. Notwithstanding any Standing Order, in the third session of the thirtieth parliament, the following bills of the second session of the said parliament shall on the opening day of the third session, be deemed to have been read a first time, ordered to be printed and dealt with as follows:

(i) Bill C-7, an act respecting the administration and development of certain fishing and recreational harbours in Canada, shall be deemed to have been read a second time and referred to the Standing Committee on Fisheries and Forestry;

(ii) Bill C-17, an act respecting the reorganization of Air Canada shall be deemed to have been read a second time, referred to and reported from a committee and ordered for consideration at the report stage;

(iii) Bill C-40, an act to amend the Aeronautics Act shall be deemed to have been read a second time and referred to the Standing Committee on Transport and Communications.

Mr. Knowles (Winnipeg North Centre): Mr. Speaker, it is correct that we have agreed to this. One point has just occurred to me. Perhaps it should be understood that in the next session these three bills will probably have different numbers.

Mr. MacEachen: Yes, Mr. Speaker, we will note that.

Mr. Deputy Speaker: Hon. members have heard the proposition of the President of the Privy Council (Mr. MacEachen). Is it agreed that the minister shall have leave to put the motion at this time?

Some hon. Members: Agreed.

Mr. Deputy Speaker: Is the House ready for the question?

Some hon. Members: Question.

Mr. Deputy Speaker: Is it the pleasure of the House to adopt the said motion?
