Thorson, Mr. J. T. (Winnipeg South Centre)

- Budget, 1852. Mr. Dunning a courageous and aggressive minister; changing the terminal of Hudson bay railway from Port Nelson to Fort Churchill; record of public debt reduction; reduction in taxation; varied and divergent economic needs of Canada, 1852; national progress made by willingness to compromise; increase in British preference; United States protectionist theory running mad; Canada's progress in foreign trade; Canada exports more manufactured goods per capita than any other country; unfavourable trade balance due to decreased exports of grain and flour, 1853; importance of grain marketing problem; trading with those who are willing to trade with us; seeking markets elsewhere than in the United States; trade relations with United States and Great Britain, 1854; Mr. Bennett and the British preference; tariff items affected by increase in British preference; British manufacturer must seek Canadian market; paying duty on containers, 1855;
