the minister make a statement in the matter? I understand that the town of Wilkie has taken it up with the Minister of Railways and with the Minister of Agriculture. If the minister is not prepared to answer to-day, perhaps I may receive an answer to-morrow.

Hon. C. D. HOWE (Minister of Railways and Canals): Mr. Speaker, I received notice of this question only a few moments ago and have not had a chance to look into it, but to-morrow I will give the hon. member such information as is available.
