

SUPPLY—CONCURRENCE

Hon. J. L. ILSLEY (Minister of Finance) moved:

That the reports of the committee of supply made to the house on February 25, 27, May 2, 13, 23, June 2, 3, 4, 5, 6 and 11, less amounts voted in interim supply be now received, read a second time and concurred in.

Motion agreed to.

WAYS AND MEANS

SUPPLY BILL

Hon. J. L. ILSLEY (Minister of Finance) moved that the house go into committee of ways and means.

Motion agreed to and the house went into committee, Mr. Vien in the chair.

Mr. ILSLEY moved:

Resolved, that towards making good the supply granted to His Majesty on account of certain expenses of the public service for the fiscal year ending March 31, 1942, the sums of \$163,431,321, \$35,000,000 and \$48,453,183.14, respectively be granted out of the consolidated revenue fund of Canada.

Motion agreed to.

Resolutions reported, read the second time and concurred in. Mr. Ilesley thereupon moved for leave to introduce Bill No. 103, for granting to His Majesty certain sums of money for the public service for the financial year ending the 31st March, 1942.

Motion agreed to, bill read the first and second times, and the house went into committee thereon, Mr. Vien in the chair.

Mr. STIRLING: I take it that both the clauses and the schedules are in the customary form. Is there anything unusual?

Mr. ILSLEY: Not that I know of. I have not the previous acts before me. There is a borrowing power in section 5 but I do not think it is at all unusual.

Bill reported, read the third time and passed.
