PASSAMAQUODDY-REQUEST FOR REPORT ON NEGOTIATIONS WITH U.S.

On the orders of the day:

Mr. Robert C. Coates (Cumberland): I have a question for the Secretary of State for External Affairs. Is the minister in a position to report on the state of negotiations between Canada and the United States regarding the development of Passamaquoddy bay from a power point of view?

Hon. Paul Martin (Secretary of State for External Affairs): There are no negotiations between the government of the United States and the government of Canada on this subject. There have been technical discussions for the purpose of considering the next step only.

BAY OF FUNDY-REQUEST FOR REPORT ON INVESTIGATION

Mr. Robert C. Coates (Cumberland): I should like to ask the Minister of Transport when the house may expect a report from the minister and the Atlantic development board with regard to the investigation being carried out concerning the feasibility of harnessing the bay of Fundy tides?

Hon. J. W. Pickersgill (Minister of Transport): I will be delighted to give such a report when my estimates are before the house.

Mr. Coates: In view of the importance of the development of the bay of Fundy power potential, will the minister give consideration to providing a report at an earlier date than when his estimates are before the house?

Mr. Pickersgill: This matter, as I think I indicated at the last session, is under study at the present time and the study has not been completed. There would be no advantage in attempting to make a report until there is something upon which to report.

PAYMENT OF GRANT TO NEW BRUNSWICK COMMISSION

Mr. J. Chester MacRae (York-Sunbury): I should like to ask the Minister of Transport whether all or any portion of the \$20 million grant allocated by the Atlantic development
