# Hon. Eric W. Kierans (Postmaster General and Minister of Communications): 1. No.

2. The Government of Canada has not changed its policy regarding the launching of the Canadian communications satellite. Only two countries are able to place satellites in a geostationary orbit: the U.S.S.R. and the U.S.A. In fact, only the U.S.A. have achieved this objective. We have negotiated with success an agreement in principle and now Telesat is negotiating the commercial details.

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): It is the policy of the Director of Investigation and Research under the Combines Investigation Act to scrutinize all significant price movements which come to his attention and he is charged with the responsibility of initiating an investigation whenever he has reason to believe there has been an offence against the Act. It is the practice, however, that no information is given out as to whether an inquiry is being pursued with respect to a particular group of companies or individuals unless and until a report is published.
