## Question No. 1,812-Mr. Fairweather:

- 1. Who were the candidates awarded places by virtue of the permanent investigator support program of the Medical Research Council?
- 2. Did the successful candidates possess the highest rating of all candidates applying?
- 3. From what universities did the successful candidates come?
- 4. What is the basis of the composition of the executive committee of the Medical Research Council?
- 5. What is the rationalization for the decision to rate various medical school departments, and does the policy take into account the financial resources of a medical school?
- 6 How is the overall national interest in medical scientific excellence preserved in the method of selection?
- 7. Does the Medical Research Council have regular communication with medical schools and working scientists concerning policy changes?

Hon. John C. Munro (Minister of National Health and Welfare): 1. The successful candidate for Medical Research Council Associateships to be taken up in 1970 were Dr. L. Branda, Dr. K. Lederis, Dr. E. Regoeczi and Dr. A. J. Wahba.

- 2. The four successful candidates were the only candidates who in the opinion of the Council met all the criteria, both scientific and developmental, which Council has agreed to apply to the selection of new Associates.
- 3. One candidate comes from the University of Calgary, one from the University of Sherbrooke, and two from McMaster University.
- 4. Under the terms of its Act, the executive committee of the Medical Research Council is composed of the President and the Vice-President of Council and six other members elected by Council.
- 5. Recognizing the great disparities that exist in health science research in various regions and in various subject areas in Canada, the Medical Research Council has taken steps to redress this imbalance. It sets aside funds for its Associateship and Negotiated Development Grant programs for the explicit purpose of stimulating high quality research in areas which are in need of development. To provide some of the background material for the operation of these programs, the Council has studied the research effort in the various medical school departments and among other things has taken into account
