Mr. Mazankowski: On a point of order and with all due respect, Mr. Speaker, since park officials are now engaged in mercy killing of elk and other wildlife, with the meat being of no saleable—

Mr. Speaker: Order, please. I appreciate the additional circumstances mentioned by the hon. member, but he has noted that the parliamentary secretary has taken notice of the question.

Mr. Mazankowski: On a point of order, Mr. Speaker, I would merely like to ask the parliamentary secretary whether he can give the House and the people of Canada an assurance that such a situation will not happen again in the future?
