### PUBLIC WORKS

CHURCHILL, MAN.—IMMEDIATE IMPLEMENTATION OF REDEVELOPMENT PROGRAM

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, my question is for the Minister of Public Works. Having regard to the growing economic distress in Canada and its particular impact upon the northern parts of our country, is the government planning to implement immediately its recently announced redevelopment program for Churchill. Manitoba?

Hon. Arthur Laing (Minister of Public Works): Yes, Mr. Speaker, we are proceeding together with the government of the province of Manitoba. We were awaiting their approval as to their participation. We have now received it and we shall be proceeding on schedule.

Mr. Dinsdale: Does this redevelopment plan involve the modernization of the Port of Churchill and, if so, what amounts are likely to be expended on this aspect of the program?

**Mr. Laing:** At this stage there is no provision for further investment in the port itself. The proposal is in essence, to close the camp and to move the people who are now at the camp into the town of Churchill itself.

Mr. Robert Simpson (Churchill): Can the minister say whether work of this nature will be conducted during the coming winter having regard to the unemployment situation in Churchill?

Mr. Laing: The sums we had set aside for this year are on target. I would think that if the province of Manitoba would like to move the work forward more rapidly we would see what we could do on our side.

### ADMINISTRATION OF JUSTICE

LEGALITY OF GOVERNMENT FINANCED EXPERIMENT RESPECTING MARIJUANA

Mr. Eldon M. Woolliams (Calgary North): I should like to ask the Minister of Justice a question. I asked this question the other day of the Minister of National Health and Welfare. The Minister of Justice was away briefing the wheat case. My question is this: Has he referred the decision to provide \$100,000 to cover the cost of an experiment respecting marijuana by a university to the legal officers of his department with a view to determining whether that action is within the law?

Hon. John N. Turner (Minister of Justice): I shall have to take that question as notice and give an answer later.

received any communication from the Saskatchewan Minister of Labour asking him to intervene in the Eldorado dispute and, if so, what initiative does he plan to take?

Hon. Bryce Mackasey (Minister of Labour): Yes, Mr. Speaker. I received such a request last week from the Minister of Labour for Saskatchewan pointing out the economic hardships that have resulted from this strike which is now of two months duration. The letter was a very objective one, and I would urge the company, which is a Crown corporation, to act as a good employer, get back to the bargaining table at the first opportunity and resume negotiations with the union.

LIFT PROGRAM—REQUESTS TO FARMERS FOR REPAYMENTS—POSSIBILITY OF PROSECUTIONS

I would need more information before I could answer the question.
