**Mr. Lewis:** —with regret and distress that in my view, and in the view of my colleagues, no progressive person could support this budget and live with himself.

**Some hon. Members:** Hear, hear!

**Mr. Lewis:** It does little if anything to combat the cost of living. No wonder the Minister of Finance keeps on repeating that he is certain things will get worse. He knows it, and he is making certain that that will happen. The budget does nothing for pensioners and low income people; it does nothing to solve the housing crisis; it does nothing to introduce real equity in our tax system; it does nothing to regain control of the Canadian economy; it does nothing to remove the regional inequalities from which this country suffers.

Because the budget fails in all these important areas, I move, seconded by the hon. member for Winnipeg North Centre (Mr. Knowles):

That the amendment be amended by changing the period at the end thereof to a comma, and by adding immediately thereafter the following words: "and its failure to propose any measures to assist pensioners and other Canadians on low and fixed incomes, to deal with the housing crisis, or to remove the glaring inequities in the taxation system".

**Some hon. Members:** Hear, hear!

**An hon. Member:** Goodbye, Pierre.

**Mr. Lewis:** So that the amendment as amended would read:

[Mr. Lewis.]

This House does not have confidence in the government by reason of its failure to propose effective budgetary measures to contain and reduce inflation and its failure to propose any measures to assist pensioners and other Canadians on low and fixed incomes, to deal with the housing crisis or to remove the glaring inequities in the taxation system.
