Mr. Diefenbaker: On a point of order, Mr. Speaker, for more than a month I have endeavoured to get an answer to question 544. From time to time I have communicated with the minister's office, on each occasion being promised an early reply. Finally, because I could not get any answer, I placed this question concerning the commissioning of statues of Right Hon. R. B. Bennett and Right Hon. Arthur Meighen on the order paper. One week ago I again placed this matter on the order paper as a starred question. I cannot understand why the government has no record of this or is unable to furnish an answer. I understand that for the last several years these statues have been in storage. I wonder why they are there, and also why, although the Right Hon. Arthur Meighen was prime minister before Mr. King, Mr. King's statue is on Parliament Hill, but not Mr. Meighen's. It is impossible, apparently, to secure information concerning the whereabouts of these two statues. I hope that the department will pay some attention to this because I know the scriptural admonition "seek and ye shall find" will certainly bring results.

SUGGESTION MINISTER OF AGRICULTURE BE GIVEN ADVICE ON HIS RESPONSIBILITIES

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, may I direct my question to the Acting Prime Minister. In view of what the Minister of Agriculture told the press outside the House yesterday when he said he is not sure of the division of authority and responsibility as between himself, the National Farm Products Marketing Council and the Canadian Egg Marketing Agency, will the Acting Prime Minister make available to the Minister of Agriculture all necessary legal advice so that the minister may be provided with all facts relating to this authority and responsibilities.

Hon. Mitchell Sharp (Acting Prime Minister): Yes, Mr. Speaker.

Mr. Stanfield: Mr. Speaker, in view of the difficulties the minister must be experiencing and in view of the gray area which may exist, from the point of view of the minister—

Mr. Hees: And that doesn't mean Herb, either.

Mr. Stanfield: —what steps does the Acting Prime Minister propose, to make certain that the Minister of Agriculture receives proper advice on the subject.

Mr. Sharp: Mr. Speaker, the Minister of Agriculture is performing magnificently in his portfolio.

Some hon. Members: Hear, hear.

Mr. Sharp: I know the opposition wants to downgrade him, but I do not think that will happen.

Mr. Diefenbaker: Ask Mrs. Plumptre.
